#### **Important Instructions:**

- 1. All the provisionally eligible candidates, who are not holding any seat by allocation, are eligible to participate in the Spot Counseling and Spot admission.
- 2. All the candidates who have been allocated any seat in any previous round of seat allocation and have joined/reported on an allocated seat as per procedure of joining/reporting & holding the seat are not eligible for the stray round/SPOT counseling and SPOT admission.
- 3. The candidates with minimum percentile in INI-CET (January-2024) as mentioned below against each category and not joined or hold any seat in INIs for January, 2024 session are eligible to attend the Spot Counseling.
  - a. For seats under Unreserved (UR), Foreign Nationals including Overseas Citizens of India (OCI) will be 50th percentile.
  - b. For OBC, SC, ST, PwBD, and Bhutanese Nationals seats will be 45th percentile.
- 4. Candidates provisionally eligible and willing to attend the Spot Counseling should have to bring all the Original documents with them and those who will opt the seat during the counseling will have to join immediately on the same day i.e. 29.02.2024 and also have to submit the original documents at the time of counseling. No request for extension of joining shall be entertained. List of documents/Certificates that are required to be deposited in Original along with one set of self-attested photocopies are given below:-
  - 1. INI-CET (January-2024) Score card.

  - Final Registration Slip
    Admit Card issued by AIIMS New Delhi
  - 3. Mark Sheets of MBBS/ 1st, 2nd and 3rd Professional Examinations.
  - 4. MBBS Degree Certificate.
  - 5. Internship Completion Certificate/Certificate from the Head of Institution or College that the candidate will be completing the internship by 31st January, 2024.
  - 6. Permanent/Provisional Registration Certificate issued by NMC/State Medical Council.
  - 7. High School/Higher Secondary Certificate/Birth Certificate as proof of date of birth. (Matriculation)
  - 8 The Candidate should also bring the valid category certificate (SC/ST/OBC) in Original issued by the competent authority, if applicable.
- 5. Foreign National/Bhutanees Nationals seats will not be converted against any other category.
- 6. No Foreign National/Bhutanees Nationals candidate will be allowed to join the MD/MS course without registration with National Commission of India.
- 7. Selected candidates will have to deposit course fee/security amounting Rs. 4470/through debit card on the spot to provisionally confirm their seat.
- 8. Any seat accrue till the date of holding counseling would be filled up and this will change the status of seats available indicated in this notice. Hence, above seats are tentative and are subject to change.

- 9. Eligible and interested candidates are requested to be seated in auditorium at 09:30 AM on 29.02.2024.
- 10. Any candidate submits false information for example:
  - a) Submitting a document which is not issued between dates as prescribed in the prospectus and submitted by a candidate to obtain eligibility despite knowing the fact that certification is not valid as not issued as prescribed in prospectus.
  - b) Applying in anticipating of obtaining desired qualification and not obtained on the date as required.
  - c) False reporting on caste, age, gender, date of acq uiring eligibility, date of completion of internship.
  - d) Any other information which is not true as required in prospectus/ notice and submitted in order to dispute at later stage.
- 11. If it is established, at any time during the process of Seat allocation of INI-CET January, 2024 or later, that applicant has deliberately furnished incorrect information for the purpose of falsification, it shall be treated as an attempt to cheat and the candidature shall be annulled and further legal and disciplinary actions will be taken.
