

NOTICE

Urgent attention candidates:

1. No AIQ seats will be reverted back to the State after completion of AIQ Round 2 for both Tripura State NEET UG 2022 Counselling and Tripura State NEET PG Counselling
2. Intending eligible Candidates who wants to resign any admitted/allotted seat are advised to ensure that their relieving letter is issued by the allotted College for relieving the candidates from their allotted seats after receiving the resignation letter from the candidate.
3. Any resignation letter by a candidate shall not be accepted unless and otherwise endorsed/certified by the admitting Institution of that candidate willing resignation from any seat.
4. In case a candidate applies for up gradation and participates in Round-2 counselling for an upgraded seat but is not upgraded and now wants to resign his/her Round-1 admitted seat, in that event he/she will have to resign from that Round-1 seat and get a releasing letter from the admitted institute within 48 hours of Round-2 result publication.
5. In case a candidate gets an upgraded seat or a fresh seat in Round-2 but does not want to retain the seat or does not want to get admitted to that seat, he/she will have to resign from the allotted seat within 48 hours of result publication of Round-2 and in this case the security deposit for Round-2 participation will be forfeited and the candidate can participate in the MOP UP Round subject to availability of seats.
6. A candidate once got admitted to a Round-2 allotted seat, his/her Counselling ends at that point and he/she cannot resign the seat even if he/she forfeits his/her security deposit. If he/she still wants to discontinue the course against the admitted seat in round-2, the penalty as per Discontinuation bond executed by the candidate shall on apply him/her which has to be borne by the candidate to the admitting College authority or the Govt. of Tripura.
7. A candidate cannot hold (get admitted to) 2(two) seats in two different State or AIQ Counsellings at any one point of time.
8. To get eligibility for the State Quota domicile seat, a candidate must have stated/submitted the State of Tripura in his/her Permanent Address in his/her application for NEET UG 2022 exam as a mandatory pre requisite to be eligible to participate in the Counselling for the State Quota seats along with other documents of domicile & eligibility which is needed to be reaffirmed accordingly
9. The seat matrix of the State Quota seat will be published subject to availability of fresh seat(if any) following roster verification, before the start of the 'Registration'. If any seat becomes available after start of registration, it will be reflected in the seat matrix of the next Round.
10. After publication of provisional allotment result, the allotted candidate will have to report in the office of the Directorate of Medical Education, Bidurkarta Chowmohany for receiving nomination letter on the scheduled date of reporting with photocopies of all original documents along with 04(four) passport size photos. Necessary bond formalities will have to be executed by the candidate before getting nomination letter.
11. In the Tripura State NEET UG 2022 online Counselling, the information regarding domicile given by a candidate during registration of Round-1 will be carried forward up to 'choice filling' event only. Online Scrutiny/screening of information s/documents will be done before allotment. Candidate who submitted his/her permanent resident as Tripura in the application of NEET 2022 Exam will be taken up only for further review and reaffirmation of eligibility.
Physical verification of all original documents of an allotted nominated candidate will be done before admission in the allotted Institution and following successful verification of physical documents. An eligible intending nominated candidate will get admission only after satisfying other admission formalities.
