- 1. The candidates of other States are not eligible for the Competent Authority Quota seats if they do not satisfy Local status/Non-Local status as per G.O.P.NO. 646, Education (W) Department, Dated 10th July, 1979 of Government of Andhra Pradesh (Presidential Order)
- 2. In view of lowering of cut-off percentile of NEET PG-2024 released by MCC, New Delhi dated 04-01-2025 issued in accordance with the Ministry of Health & Family welfare, Govt. of India Letter No.U-12021/05/2024-MEC, dated 04-01-2025, Dr. NTR UHS invites Online applications from the eligible In-service & Non-service candidates for admission into vacant/un-filled seats of Post Graduate Medical Degree/Diploma Courses under Competent Authority Quota seats in Government and Private un-aided Non-Minority & Minority Medical Colleges in the State of Andhra Pradesh including SVIMS, Tirupati for the academic year 2024-25.
- 3. Candidates who have already applied for the 2024-25 academic year and are included in the Competent Authority (CQ) Merit Lists for In-Service and Non-Service categories do not need to reapply. All other application requirements outlined in the previous Notifications/Prospectus dated September 27, 2024, remain unchanged.
- 4. Candidates should be aware that only seats that remain unfilled, were not reported, or were vacated through free exit after the completion of Phase-II (Non-Service) or Phase-I (In-Service) including PwBD will be available for subsequent phases of counselling, subject to eligibility.
- 5. The Candidates are advised to take a printout and read the Prospectus carefully before applying.

General/EWS	15 th percentile and above	
SC/ST/BC(A/B/C/D/E)/PwD	10 th percentile and above	

- 7. Cut-off date for completion of Internship: 15-08-2024.
- 8. Service rendered up to 16-04-2024 shall be considered for considering candidates under In-service Quota seats.
- 9. Service candidates should not have completed 50 years as on 16-04-2024. Candidates born on or before 16-04-1974 are not eligible for In-service quota seats only.
