**ADMISSION INTO BDS COURSE UNDER COMPETENT AUTHORITY QUOTA FOR
THE ACADEMIC YEAR 2025-26**

**NOTICE TO THE CANDIDATES FOR CALLING FRESH WEB OPTIONS UNDER
SPECIAL STRAY VACANCY ROUND OF WEB-BASED COUNSELING**

Keeping in view of the NEET-UG Special Round Schedule- 2025 notified on 17.12.2025 by the Medical Counselling Committee (MCC), O/o DGHS, Ministry of Health & Family Welfare Dept., Govt. of India, the Competent Authority for admissions under State Quota has decided **to conduct Special Stray Vacancy Round of web-based Counselling for admission into BDS Course under the Competent Authority Quota (Convenor) seats** for the academic year 2025-26 **duly calling for fresh web options from the eligible as per the following schedule:-**

1) SECURITY DEPOSIT:

The eligible candidates who are willing to participate in Special Stray Vacancy Round of counselling under Competent Authority Quota have to pay a **Refundable Security Deposit Amount of Rs.10,000/- (Rupees Ten Thousand only)** through online mode before exercising web options, subject to the conditions:

- Refundable Security Deposit of candidates who do not join the seats allotted to them in Special Stray Vacancy Round, if any, will be forfeited.
- If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).

2) NO OF SEATS AVAILABLE:

A total of '63' BDS seats under Competent Authority Quota are available for Special Stray Vacancy Round which are fallen vacant due to non-joining of candidates who were allotted seats under BDS CQ Stray Round. Detailed Seat Matrix is displayed in the University Website.

3) ELIGIBLE CANDIDATES: Candidates present in the Provisional Final Merit List displayed on 19-08-2025 and **NOT HOLDING** any seat either under State Quota (Competent Authority Quota or Management Quota) or All India Quota are only eligible to participate in this Special Stray Vacancy Round of Counselling.

4) NOT ELIGIBLE CANDIDATES:

- Candidates who are already joined MBBS / BDS Course under State Quota (either Competent Authority Quota or Management Quota)
- Candidates who are holding any seat (MBBS/BDS) under All India Quota.
- Candidates whose data shared by the MCC allotted under Special Stray Vacancy Round.
- Candidates found ineligible to pursue the course, if any.

5) **WEB OPTIONS:**

- a) **Onetime Web options exercised earlier as per notification dt:01-10-2025 will be treated as 'Null & Void'.**
- b) **Eligible candidates will have to exercise fresh web options for the Dental Colleges having BDS seats under Special Stray Vacancy Round as per the seat matrix displayed in the University website.**
- c) A candidate has to **exercise prioritized web options for only the interested Dental colleges** in the order of priority as per his/her choice **which includes Special Categories i.e. NCC and Sports & Games.**
- d) **EXERCISING WEB OPTIONS FOR ALL COLLEGES IS NOT COMPULSORY.**
- e) Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.
- f) The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
- g) Candidates participating in Special Stray Vacancy Round will have to furnish an undertaking with respect to allotment of seats at the time of exercising web options as under:

"I agree to participate in the Special Stray Vacancy Round of Dr. NTRUHS. I affirm that I am not holding any seat in the previous rounds of NEET UG Counselling, 2025 of All India Quota/State Quota.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Special Stray Vacancy Round, I will join the allotted seat. If, due to any reason I do not join the allotted seat my refundable security deposit will be forfeited and any action including legal may be taken by the Competent Authority."

6) **SELECTION PROCEDURE:**

- a) Rule of reservation shall be followed as per the procedure notified on 18-08-2025
- b) If eligible candidates against special category (NCC / Sports & Games) seats are not available, the said seats will be added to respective categories and filled as per rules.
- c) General Conversion procedure will be followed as notified.
- d) **Conversion of Minority Seats**
 - i)) If no eligible Minority candidates are available, then the unfilled seats will be converted to AP Unreserved and filled with eligible Minority candidates.
 - ii) Even then also, if no eligible Minority candidates available, the seats will be filled with other than Minority candidates by order of merit.

7) **FEES :**

- a) **a) University Fee:** The selected candidates have to pay **University fee of Rs.10,600/-** through payment Gateway by using Online payment method (Debit Card / Credit Card / Internet Banking) for downloading the allotment order. The University fee once paid shall not be refunded under any circumstances.
- b) Tuition Fee:** → **Rs.9,000/-** per year in Government Dental Colleges.
→ **Rs.14,300/-** per year For Category-A seats in Private Dental Colleges.

8) **INSTRUCTIONS TO THE CANDIDATES:**

- b) Candidates are advised to go through the Prospectus, Government Orders on Rules for UG admissions, Information on Counselling Procedure available in the University website, before exercising.
- c) Candidates are instructed to take the printout of the saved options.
- d) Mere exercising prioritised web options under this notification does not confer any automatic rights to secure admission into BDS Course.
- e) Candidates are cautioned that if a seat is allotted and the candidate is later found ineligible, the allotment will be automatically cancelled without any notice.

- f) Candidate will receive message to his / her registered mobile, if seat is allotted. The candidates are instructed to visit the website for status of allotment after closure of web options.
- g) Candidates who have been allotted a seat under this notification should report **compulsorily** at the allotted college within the reporting schedule as prescribed in the provisional allotment order.
- h) Verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University regulations.
- i) Decision of the Competent Authority is final.
