In continuation to this office notification dated **26-12-2025**, the following Schedule is hereby notified for **Special Stray Vacancy Round under Management Quota** for admission into BDS course, 2025-26.

1) ELIGIBLE CANDIDATES:

All the candidates whose names are present in the Final Merit Position displayed on 22-08-2025 and subsequent eligible lists notified on 19-09-2025, 01-10-2025, 24-10-2025, 17-11-2025, 20-11-2025 & 27-12-2025 in the University Website and **NOT HOLDING** any seat (MBBS/BDS both under State Quota or All India Quota) are only eligible to exercise web options as per the above schedule subject to the conditions laid down in the information on Counselling Procedure notified on 23-08-2025.

2) NOT ELIGIBLE:

- Candidates already allotted and joined a seat (MBBS / BDS) in All India Quota / State Counselling/ Deemed University.
- Candidates who will be allotted under Competent Authority Quota of Special Stray Vacancy Round of Dr NTR UHS, Vijayawada.
- Candidates found in the list shared by Medical Counselling Committee (MCC) after Special Stray Vacancy Round.

3) SECURITY DEPOSIT:

As already notified, the eligible candidates who are willing to participate in Stray Round of counselling under Management Quota have to pay a **Refundable Security Deposit Amount of Rs.2,00,000/- (Rupees two lakhs only)** through online mode before exercising web options, subject to the following conditions:

- Refundable Security Deposit of candidates who do not join the seats allotted to them in Stray Round, if any, will be forfeited.**
- If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.

- iv. Also, the Security Deposit will be forfeited, if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).
- v. The candidates who have paid Security Deposit of Rs. 3,00,000/- for MBBS course as per notification dt:26-12-2025 and not allotted any seat can also exercise web options for BDS course without payment of Rs.2,00,000/-.

NOTE: List of eligible and not eligible candidates for refund of Security Deposit will be displayed in the University website after closure of Admissions only.

4) **University Fee:**

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

6) **Instructions to the Candidates:-**

- Candidates are advised to go through the Prospectus / Regulations of Dr. NTR UHS available on website before exercising web options.
- The allotments will be as per the prioritized options exercised by the candidates.
- If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Stray Vacancy Round of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Dental Colleges.

4. **Options:**

- a. Subject to payment of security deposit amount, the eligible candidates who are aspiring to join under Management Quota under this phase have to exercise prioritized web options as per the schedule notified.
 - b. A candidate has to exercise options for the interested Dental colleges in the order of priority.
 - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and email at the time of entering and submitting web options.
 - d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
 - e. Candidates are instructed to take the printout of the saved options.
5. Candidates have to exercise options for category - B seats and if eligible, for Category - C (NRI) in order of priority of the colleges. Allotments will be made according to the order of preference in the web options exercised by the candidate and as per rules.
 6. Candidates will receive the message regarding allotment of seat, if seat is allotted.
 7. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
 8. Candidates who are allotted seat in Special Stray Round of counselling have to report to the allotted college **compulsorily** with all original certificates (freshly allotted), provisional allotment order, copy of final application, and pay the tuition fee and college fee. Such candidate cannot resign the seat allotted.
 9. Candidates allotted seat under NRI Quota should produce the relevant sponsorship Declaration from NRI in Original along with supporting documents as specified in the Prospectus, at respective colleges.
 10. The University fee once paid shall not be refunded or adjusted to a future date under any circumstances.
 11. Decision of the Competent Authority is final.
 12. Dr. NTR University of Health Sciences does not entertain or support seat blocking/ cancellation of BDS seats. In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.
