In continuation to this Office Notifications, dt.18-09-2025, 27-09-2025 & 29-10-2025 Dr. NTR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-I of counselling for both **In-Service and Non-service candidates** for admissions into Competent Authority Quota (CQ) PG Medical Degree/Diploma courses available in the Government and Private Non-Minority and Minority Medical Colleges under Dr. NTR UHS and SVIMS, Tirupati for the academic year 2025-26 for the seats available in the following colleges:

- a) Seats available (after contributing 50% of seats to All India Quota) in Government Medical Colleges in the State of Andhra Pradesh, affiliated to Dr. NTR UHS.
- b) Category- A Convenor Quota seats (50% of Intake) in Private Un-aided Non-Minority and Minority Medical Colleges in the State of Andhra Pradesh, affiliated to Dr. NTR UHS.
- c) 31 State Quota seats in SVIMS, Tirupati.

Instructions to Candidates:

- Seat Matrix is displayed in the University Website https://drntr.uhsap.in for information of the students. All the eligible candidates present in the Final Merit list displayed on 15-11-2025 and subsequent corrigendum if any are eligible to opt for Phase-I.
- Newly sanctioned/enhanced seats as per NMC Notice, dt.30-10-2025 & 27-11-2025, if any will be filled in Phase-II counselling subject to receipt of Affiliation orders.
- Candidates are advised to go through the Prospectus (placed in the University website on 18-09-2025) and the Government Orders on Rules of PG admissions available before exercising web options. Candidates are also advised to go through the details about "MRC" concept which is exemplified below:

Example:

- a) In a particular college MD(RD) seat is under "Open Category" in the seat matrix and a SC candidate is allotted that Open Category MD(RD) seat in Open Round Counselling of Phase-I as per his/her web options and NEET Rank merit order of the candidate. Now this candidate is shown as **Meritorious Reserved Candidate** (MRC).
- b) The same SC candidate has slided to MD (General Medicine) SC category seat in the same college or another college during the Category Round of Phase-I Counselling **conducted on the same day**, then that MD(RD) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.
- c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50: 50 ratio of Open: Category Reservation

- Filling up of PG (Medical) Seats in Siddhartha Medical College, Vijayawada for the academic year 2025-26:

The Government of Andhra Pradesh vide G.O.Rt.No.475, HM&FW (C1) Dept., dt.22-07-2025 ordered "to continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution and admissions to 85% of the available seats (after deducting All India Quota seats) shall be divided between local candidates of Andhra University and Sri Venkateswara University regions in the ratio of 65.62% and 34.38%, with the remaining 15% treated as unreserved.

The definition of local candidates and eligibility in respect of 85% local seats and 15% unreserved seats shall be as per respective admission rules of Undergraduate Medical and Postgraduate Medical courses applicable to Government Professional Institutions."

- As per the year 2024-25 Notifications for Stray/Special Stray rounds of CQ/MQ counsellings, candidates who participated in Stray/Special Stray rounds of CQ/MQ counsellings conducted for the year 2024-25 and allotted seats but not reported/joined are debarred for admissions into CQ/MQ counsellings for the year 2025-26 (List of debarred candidates displayed on the University website).
- As per G.O.Ms.No.67. dt.21-04-2017, the candidates who have discontinued the course from the academic year 2022-23 irrespective of their admission batch will be debarred for this academic year i.e., 2025-26 (List of debarred candidates displayed on the University website).
- 7 Candidates opting for Medical Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of specialities and colleges available.
- 8 Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are genuinely interested. If they are not interested to join any speciality or college then they are advised not exercise options for the same and avoid seat blocking.
- The Eligible PwBD candidates can exercise web options only for the specialties recommended by the Medical Board, as notified in the PwBD candidates Eligible & Not Eligible list, displayed on University website on 15-11-2025.
