PUBLIC NOTICE

Subject: Online application for the Eligibility Certificate for the forthcoming session-regarding

The Foreign Medical Graduate examination (FMGE) Screening Test may be scheduled tentatively in the month of June, 2022 by the National Board of Examinations in Medical Sciences and as per the requirements, the candidates are not permitted to apply for Screening Test without the Eligibility Certificate issued by the National Medical Commission. The candidates who have taken admission to a foreign medical college on or after 05 June 2019, do not require the Eligibility Certificate since their NEET qualifying certificate would be their Eligibility Certificate for purpose of taking the exam.

2. As per the erstwhile MCI, now National Medical Commission notification, candidates going abroad after 04 January, 2014 to pursue Primary Medical Qualification (MBBS or its equivalent) must obtain the Eligibility Certificate prior to proceeding abroad. As a special relaxation for those who did not take the Eligibility Certificate before proceeding abroad are also requested to submit the application.

3. However, an Indian national/Overseas Citizen of India who intends to take admission in MBBS or equivalent medical course in any medical college of Pakistan are required to obtain eligibility certificate from the National Medical Commission in addition to qualifying NEET, and such person(s) would not be exempted from the requirement of obtaining eligibility certificate u/s 13(4B) of the Indian Medical Council Act, 1956.

4. All candidates requiring Eligibility Certificate are requested to apply through National Medical Commission's website <https://www.nmc.org.in/ActivitiWebClient/open/studentRaise> as per the schedule given below:

Incomplete application will not be processed and shall be summarily rejected. Thereafter the portal for applying the application shall be closed.
