**UNDERGRADUATE AND POSTGRADUATE COURSES FOR THE ACADEMIC YEAR 2021-22**  
**WITH EFFECT FROM 14-04-2022**  
**RECOMMENDING TO THE NATIONAL MEDICAL COMMISSION ON WITH DRAWAL OF**  
**RECOGNITION TO THE COLLEGE BOTH UNDERGRADUATE AND POST GRADUATE COURSES**

**Sub:** Pacific institute of medical sciences, Udaipur, Rajasthan under Sai Tirupati University, Udaipur - application for renewal of permission for MBBS course for batch against the annual intake of 150 MBBS seats for the academic year 2021-22 u/s 26(1)(a)(b)(c)(f) 28(7), 38(1)(a) and section 61(2) of NMC act, 2019 – a sworn affidavit was submitted -surprise assessment dated 24th February, 2022 - major deficiencies -show cause notice – withdrawal of letter of permission, Cancellation of admissions into undergraduate and postgraduate courses for the academic year 2021-22 with effect from 13-04-2022 - Recommending to the National Medical Commission for withdrawal of recognition to the college for both undergraduate and post graduate courses\_ regarding

The Pacific Institute of Medical Sciences, Udaipur, Rajasthan under Sai Tirupati University, Udaipur was granted Letter of Permission in the year 2015-16. The Commission received application for renewal of Permission for MBBS Course for 5<sup>th</sup> renewal (6<sup>th</sup> batch admissions). The college was not granted batch permission in the academic year 2018-19. The batch recognition for 2015-16 was granted in the year 2021-22, in view of the Pandemic COVID-19. The college is not recognized and is due. The college has applied for Postgraduate courses and the NMC has approved postgraduate seats for the academic year 2021-22.

The Medical Assessment & Rating Board of National Medical Commission has received several complaints on fake faculty and inadequate patients to provide hands on training. To verify the complaints a surprise assessment was conducted on 24<sup>th</sup> February 2022 u/s 26(1)(a)(b)(c), 28,38 and section 61(2) of the NMC Act, 2019, and found the following major deficiencies.

Out of the required 150 faculty members, only 70 faculty members were present (physically verified) till 12 noon. The deficiency of 54.88% was noted. A total of 05 Senior Residents out of the required 45 were present, deficiency of 88.88% was noted. A total of 29 Junior Residents were present of the required strength of 56 with the deficiency of 34.14% was noted.

**A. Department Of General Medicine**

**1. Faculty for teaching of Undergraduate and Post Graduate students:**

- Faculty and Infrastructure is calculated as per Old MSR of NMC regulations applicable for 150 MBBS students and Post Graduate training.
- At the time of attendance taken at 12 noon, only 5 faculty members were present at the time of inspection at 12 noon- 1 Professor, 1 Assoc Prof, 3 Asst Prof. Later 01 Assistant Professor came at 12.45pm.

- To run the Post Graduate training with 150 UG students as per regulations, the required faculty are One Professor, Five Associate Professors and Nine Assistant Professors, Five Senior Residents and Ten Junior Residents. **The net deficiency of 04 Associate Professors and 05 Assistant Professors even when we considered the late attendee. No senior resident present on physical verification.**

2. Clinical Work for hands on training:

• **Clinical Work load in Department of General Medicine:**

- Patients in the ward are scanty. **Only 30 patients for 270 beds (150 General Medicine beds) in medicine including allied departments**, (respiratory, dermatology, cardiology, nephrology). Total beds required are 150 + 120 for allied specialties.
- Patient variety- Quality of clinical material for hands on training is poor quality, as the cases are routine like anemia, diarrhea except 1 or 2 cardiovascular and neuro deficits cases.
- Out of 25 bedded ICU, 15 beds are for medicine (10+5) + 10 of surgical ICU with total 64% occupancy in ICU beds.

**B. Department Of Pediatrics:**

1. Faculty for teaching of Undergraduate and Post Graduate students:

- Postgraduate seats granted were 04 in numbers in the year 2021-22.
- They need three units and 90 beds and 20 ICU beds are required, to run the 150 UG students and Post Graduate training as per regulations, the required faculty are One Professor, Three Associate Professor and Five Assistant Professors and Three Senior Residents and six Junior Residents.
- At the time of attendance taken at 12 noon, there were only two peoples were present in the Dept., one Associate Professor and one PG Student. Dr. Suresh Goyal was introduced as the Head of Dept. when he came after 1 PM. His name was not even included as faculty in list provided by the Associate Professor during attendance.
- At the time of attendance Dr. Neelam Raval was informed to be the Head of the Dept, she never came throughout the day.
- There were no other faculty members on the day of inspection. Thus the Dept. of Pediatrics including Dr. Suresh Goyal who claimed to have joined the Hospital in December, 2021, had only one Professor and one Associate Professor. This number does not meet the minimum faculty requirement for 150 UGs and PGs that the Dept. currently has.
- Also, no clear proof of Dr Goyal being Head of the Department of Pediatrics could be provided by the Hospital.

2. **Clinical Work load in Department of Paediatrics:**

- They need to have three units and 90 teaching beds and 20 ICU beds
- **As per the HMIS system, the OPD attendance on the day of inspection was 152 and there were 11 admissions in the Dept. of Paediatrics. However, an inspection of OPD revealed very few patients and there were no admissions till 1PM.**
- **In-patients: Out of 105 total Paediatrics beds in the Hospital including ICU, only 7 were occupied (1 each in two pediatrics wards, 3 in NICU and 2 in PICU).** The number of patients as per the register maintained in the Paediatrics ward did not match the number of patients observed during inspection.
- Even for those two patients admitted in the wards, clinical records were not available. On examination by us these patients did not seem to warrant admission (captured in videography).

- The quality of clinical material as per the admission registers available in the wards was not of adequate spectrum of clinical material to teach variety to meet the requirements of PG Students training.
- C. **Department of Obstetrics and Gynaecology:**
  1. **Faculty for teaching of Undergraduate and Post Graduate students:**
    - Postgraduate seats for granted 04 in numbers in the year 2021-'22.
    - They need to have three units and 90 beds and 10 ICU beds are required, to run the 150 UG students and Post Graduate training as per regulations, the required faculty are One Professor, Three Associate Professor and Five Assistant Professors and Three Senior Residents and six Junior Residents.
    - One professor was present. Four other faculty members (two each of associate and assistant professors) were present. Only two senior residents were present.
    - **Faculty shortage:** The available faculty is appropriate for sanction of 4 PGs : There was a net deficiency of one associate and three assistant professors as well as one senior resident was noted.
    - **Physical verification of faculty & residents:** During physical verification of the faculty, SRs and JRs following observations were made:
      - a. Dr Kavita Tanwar was not available for head count in the morning
      - b. Dr Archana Singhal though associate Professor, is receiving lesser pay than SRs
      - c. Dr Arpit, SR, was not available for head count in morning
    - **Record keeping:** The daily census of wards, LR, OTs and clinics is not compiled and entered in their respective registers.
    - **Departmental Library:** There are about 100 text-books in the departmental library. They have hard copies of only one national journal 'JOGI'. There is no international journal available in the library. There is no institutional access to soft copies of the journals to faculty. There is no computer or internet facility available in the departmental library.
  2. **Clinical Work load in Department of Obstetrics and Gynecology:** Old MSR of NMC regulations are applicable for 150 MBBS students and Post Graduate hands on training:
    - They need to have three units and 90 teaching beds and 20 ICU beds
    - **Bed occupancy in wards:** The actual bed occupancy of wards was discrepant from the one in the census on 24/02/2022. **The bed occupancy on physical verification was 13 out of 120 beds.** In OBG ICU 1 bed was occupied out of 5 beds available.
    - **Clinical workload:**

There was only one *delivery* in the Labour Room by 1.00PM and no CS so far on 24.02.22. The number of deliveries conducted were 01 on the day of assessment

      - There were total 8 deliveries on 22<sup>nd</sup> and 23<sup>rd</sup> February 2022, and an average deliveries for the last three years were 04 in 1<sup>st</sup> year, 3.5 in 2<sup>nd</sup> year and 4.5 in 3<sup>rd</sup> year.
      - Major Surgeries reported were 9 cases on 22<sup>nd</sup> and 23<sup>rd</sup> February. However, only 2 post-operative patients were present in the wards. Patients of major surgeries are not likely to be discharged by 2<sup>nd</sup> or 3<sup>rd</sup> PO day.
      - The census of OBGY OPD on 24.02.2022 was 203 but there were very few patients on visiting the OPD. It gives a suspicion on the work load entered in the records, as the surprise check of the patients number, quality in Out Patients, In patients, Deliveries, Surgeries from the work place, doesn't match with the records maintained.

- The specialty clinics had hardly any patients on repeated visits to the OPD though there were entries of about 15 patients in the register.
- The census of previous year (2021) appears unrealistic. The major cases done were about 1800 with an average of 5-6 major surgeries per day, more so with covid pandemic almost throughout the year.
- Similar census was reflected in the current census of major surgeries in the OT register but there were no corresponding patients in the wards. An average admission rate of 25 patients per day during pandemic seems unrealistic.

**C ) Department of General Surgery**

**Faculty for teaching of Undergraduate and Post Graduate students:**

- Faculty and Infrastructure is calculated as per Old MSR of NMC regulations applicable for 150 MBBS students and Post Graduate training. Department of General Surgery:- Postgraduate seats permitted were 02 in the academic year 2021-22.
- They need Five units and 150 beds and 10 ICU beds are required, to run the 150 UG students and Post Graduate training as per regulations, the required faculty are One Professor, Five Associate Professor and Nine Assistant Professors and Five Senior Residents and Ten Junior Residents.
- On Physical Verification of the faculty of General Surgery there were only 8 faculty present at the time of inspection at 12 noon- 1 Professor, 3 Associate Professors and 4 Assistant Professors. There are No senior resident present on physical verification.

**In-patients-**

- **Out of 150 beds only 42 beds were occupied in general surgery department. (Deficiency of 70%)**
  - **There are 05 units with 150 beds with the faculty deficiency for Undergraduates were 02 Associate and 05 Assistant Professors for UG and Postgraduate courses. 03 units were incomplete for Postgraduate training.**
  - **In the Department of Orthopedics they had 14 patients out of 90 beds**
  - **In the Department of Ophthalmology 10 patients were physically present out of a total strength of 30 beds.**
  - **Similarly only 4 patients were admitted in ENT ward out of total strength of 30 beds.**
- a) No physical attendance register/record either of the Faculty or residents was maintained. However, the College Authorities informed that they were using biometric attendance. Biometric attendance was provided.
- b) There were no Consultants/Senior residents available in any OPD during the OPD visit. However, there were Junior Residents conducting the official services.

**Summary of observations for assessment to permit PG admission:**

**II. 2<sup>nd</sup> Surprise round of wards at 5 PM:**

- i. Most patients admitted on 24/02/2022 were not found available on their beds/ in their wards.
- ii. In surgery ward, where in the morning 42 patients were found to be admitted during the visit in the ward at 5 pm most of the patients were found missing, nor the case records of new patients admitted on 24/02/2022 were available.
- iii. In pediatrics ward, there was only 1 admitted patient and none of the 10 new admissions were found in the wards.

- III. **Casualty:** During afternoon (at around 12 PM) casualty/emergency visit, there were no patients. All beds were empty. However in the admission register entry of 9 patients was there and on the other side of the register it was mentioned that patients refused admission.
- The CMO (DOD) Nikita was not physically available. She came to the hospital after phone call. No other resident Doctors was physically present in Emergency ward.
- IV. **Out Patient Department:**
- i. There were no Consultants/Senior residents available in any OPD during the OPD visit. However few junior residents were present.
  - ii. In the OPD the HIS count was reflecting very high number of entries (more than 1500) in OPD patients till 11:42 AM. However only 7-8 patients were waiting in the line in front of Registration counter for registration. During the surprised visit at 5 pm the total entry were around 1700 at that time also not even a single patient was waiting for the registration. Thus there was apparent gross mismatch between actual and entries in HIS.
  - iii. OPD : Medicine, Surgery, Ortho, Gynae and Pediatrics, there were very few patients, mostly empty
- V. **Radio-diagnosis:** There were no Professors, Associate Professors or Senior Residents or non-academic Junior residents. In the head count done at 12 noon, **there were only 3 Assistant Professors present physically** in the department and 5 PG Junior residents.
- As per the guidelines, they are supposed to have atleast 1 Professor, 2 Associate Professors, 2 assistant Professors and 3 Senior Residents. So overall there is significant deficiency in the faculty as only 3 Assistant Professors are available.
  - i. The department is well equipped in terms of radiology equipment. There are 4 static X -ray machines including 3 Digital direct and 3 CR machines, 2 Fluoroscopic machines, 3 ultrasound machines, 7 portable x ray machines, 1 128 slice CT scanner, 1 1.5 T MRI and 1 mammography machine. There is a shared DSA/cath lab with other clinical units.
  - ii. The number of X rays done were 72 on the day of assessment and the average of last 3 days were 70. This is less than the minimum requirement of 100 x rays per day as laid down in criteria by NMC which is for 3 PG seats. For 6 PG seats which have been sanctioned for this college, the total minimum requirements is around 130 X rays per day.
  - iii. The ultrasound examinations and CT scan examinations on the day of assessment as well as average for last 3 days (70 and 13 respectively) is adequate and more than the minimum criteria laid down. It was physically verified.
  - iv. The number of special investigations per day was 1-2/day on average which is less than the minimum requirement of 5 per day.
- VI. **Operation theatres:**
- a) 36 Major Surgeries was done on 24/02/2022 as per the information of the hospital however on verification it was verified that only 13 surgeries were conducted at the same time register entries of operated patients was incomplete, unsatisfactory and non-verifiable from OT list (unavailable and post of ward at 5 pm).

A show cause notice was served on 23.03.2022 and received an explanation on 05.04.2022. The explanation is not meeting the required faculty and patients, clinical load to train the undergraduate and postgraduate students. There was no substantial information to prove that the institute has required number of faculty in pre-clinical, para-clinical and clinical departments. Similar deficiencies for also noticed in tutors, Senior and Junior residents. The

explanation could not convince, that the required patients are available for training of undergraduate and postgraduate doctors. The sworn affidavit submitted was untruthful with false information to the National Medical Commission.

The above deficiencies mentioned in a show cause notice and the explanation given is summarized as below:-

1. It is not true that the surprise assessment was not conducted in proper and superficial manner.
2. All or actions from the MARB of National Medical Commission follow the NMC Act, 2019 (Erstwhile MCI).
3. The earlier reports supported to starting of undergraduate courses and also granting postgraduate seats. However, there was a missing of batch in the academic year 2018-19 due to deficiencies. We have reviewed the surprise assessment report, served the show cause notice and rectifying the deficiencies.
4. We have given the circular for renewal and batch permission as the commission could not conduct physical inspections of the medical college/institution in view of COVID, 2019. By permitting the college to admit students for the academic year 2020-21 and 2021-22 doesn't endorse any deficiencies as found in this surprise assessment.
5. There is mall distribution of doctors and medical colleges in the country. It is a duty of the institution to provide the required infrastructure, qualified teachers and the laboratories including patients to train a good and qualified doctors. We don't accept the Pacific Institute of Medical Sciences, which is having major deficiencies should not be allowed to produce incompetent doctors.

The National Medical Commission has invited a sworn affidavit for granting batch admission for those colleges, could not be granted recognition. If your institute has not submitted a sworn affidavit for admissions of 2020-21 and 2021-22, it becomes irregularity.

Granting a batch admissions of 2020-21 and 2021-22 and recognition of 2015-16 and 2016-17 batches do not endorse the recognition of your institute.

Regarding faculty and residents requirements for 150 undergraduate students and postgraduate training, we follow the attendance only. If the respective faculty and residents doesn't come and signed the register before 11 o'clock cannot be taken their presence. None of the other explanations doesn't convince us to take them as they are teaching the students. Several faculty from one department like Dermatology and pre-clinical departments attending a medical camp doesn't arise at all. There are only 05 senior residents out of 45 with the deficiency of 88.88% and 27 junior residents out of 41 with the deficiency of 31.14% in the entire hospital and all postgraduate students attending OP and wards without senior doctors is not at all acceptable and convincing, that they have adequate teachers (only 46% of the faculty are present against the requirement of 141 faculty – deficiency is about 54%).

In out-patient department, a total of 1773 out-patients registered through computer at 05:00 p.m. and 1500 at 11:42 a.m. by computer and 962 by manual registration. During the assessors' visit there are only 07-08 patients were waiting at the registration counter and there were no patients in out-patient waiting area at 05:00 p.m. There were no faculty (senior doctors) in any of the out-patients services. We do not understand that the patients of 1773 registered by computer were not seen in waiting areas, and no doctors to examining them in respective out-patients services. This further proves that the institute has created virtual patients by mere entering the names in the computer

to misguide the assessors' and creating documentary evidence of non-existent patients. In in-patients were 152 in all the wards.

In General Medicine, 30 patients against 150 beds including Respiratory Medicine, Dermatology, Cardiology, Nephrology, constitutes another 120 beds. Out of 25 ICU beds, 15 for Medical and 10 for Surgical about 20 patients were there. In Paediatrics, HMIS registered 152 children and 11 children were admitted to the ward. However, when we went to the ward, there are no patient admitted in the ward beds. The total number of patients in the ward were 07 against 105 beds including ICU. Even those patients admitted who did not have proper clinical records nor investigations and treatment records.

In General Surgery, 42 beds were occupied against 150 beds.

In Obstetrics & Gynaecology, 13 of 120 beds were occupied and 01 normal delivery was conducted.

In the operation theatre, there were only 13 operations performed on the day of assessment. Though the college claimed 33 operations. They could not substantiate the names of operations, patients' names and surgeons names and time for the remaining 20 patients. Also the details were not found in any of the registers in operation theatre, nurse in-charge and anaesthetist register as verified by the assessors.

The college further explains that there were 1773 patients who were examined and disposed off from OPs before the assessors' came for visit which is contradictory to their own statement that majority of the faculty and the residents went for a medical camp and not available in out-patients clinics, to examine the patients. Similarly, when the in-patient beds were vacant during the assessors' rounds in the morning and evening, the explanation given that, the patients were sent for investigation elsewhere, operation theatres for lunch or meeting the families or the students examining the patients somewhere is not at all convincing that there are patients in the wards.

**All the above deficiencies are major more than 50% and grossly inadequate with respect to the mandatory requirements of any medical college to permit the admissions for undergraduate and postgraduate courses. For further clarifications a table is enclosed in Annexure1.**

The teaching faculty and residents, technical staff deficiency in the college are significant and not as per the NMC guidelines. There is a gross deficiency of hospital services and lack of patients, out patients, in-patients, operation, deliveries and in emergency to train the students. The MARB of National Medical Commission has taken a serious note of the above mentioned deficiencies. On surprise assessment, as per the section 26(1)(a)(b)(c) and 28(1) (2) of the NMC Act, 2019 in the college does not have minimum required faculty, residents and clinical material including the facilities required to run an undergraduate MBBS course.

**The explanation is not satisfactory and rejected. After due deliberations, the MARB of NMC has decided to cancel the Letter of renewal of permission granted for the academic year 2021-22 for the undergraduate 150 MBBS and postgraduate in MS (OBG) 06 seats with immediate effect from 14-04-2022. Also reported to the National Medical Commission to cancel the recognition for the college.**

Further actions will be as per section 26(1)(a)(b)(c)(f) 28(7), 38(1)(a) and section 61(2) of the NMC Act, 2019.
