Sub: No salary/pay/wages/stipend deduction and regular payment to the faculties, students and other employees working in the self-financed dental colleges/institutions during lockdown period due to COVID-19 – Regarding.

Sir/Madam,

By now we all are aware of the disastrous situation that has been created by the COVID 19 pandemic globally as well as in India. Last few weeks we have also seen the fight put up by our government and all the healthcare personnel ably aided by other emergency service agencies and people attached to them. Saying this, we can also feel that this war against Corona virus is far from being over.

The only way for us apart from the healthcare measures, are to keep our own morale high and support our government and the people fighting this war at the frontline by following their instructions to the word.
