**NOTICE**

**Subject: Modified Schedule for the 2<sup>nd</sup> and subsequent rounds of DNB Counseling.**

1. Pursuant to the Notice No. U-12021/44/2019/51-MEC Dated 16/06/2020 issued by the **office of ADG-(ME), Directorate General of Health Services, Govt. of India**, the Physical Reporting of Round 1 and Round 2 candidates of All India 50% Quota Counseling has been extended till **30<sup>th</sup> June 2020**. **To avoid blocking of DNB seats**, the current Adding/Editing/Reordering of filled Options/Choices for the 2<sup>nd</sup> round of DNB counseling ongoing from 15<sup>th</sup> -19 June 2020 vide Public Notice dated 03/06/2020 stands **NULL & VOID**.
2. The revised schedule for the **2<sup>nd</sup> Round** of the Centralized Online Merit Based counseling for admission to DNB (Post MBBS) and DNB (Post Diploma) courses for 2020 Admission Session is tabulated below. **Candidates are required to fill their options/choices of DNB seats once again in accordance with the revised schedule.**

3. Candidates have the option to add/edit/modify the choice of seats indicated by them in the 1<sup>st</sup> round of counselling. Candidates are advised to fill their preferences of seats carefully and **Lock and Confirm** it so that the same are considered by the **System**. If there is **INACTION** i.e. the candidate does not

**Lock and Confirm** the preference of his/her choices, the **System** will not accept the choices of seats **and the candidate will not be allotted any seat.**

4. Candidates who will be allotted a DNB seat in the 2<sup>nd</sup> round of counselling may note that If there is **INACTION** i.e. the candidate neither chooses **YES** for locking and Freezing of the seat leading to payment and exit from the counselling process nor chooses **NO** which leads to release of the seat and opting for proceeding for 3<sup>rd</sup> round of counselling, the **System** will read the **INACTION** as **NO** with release of the Allotted seat and the candidate will be moved by the **System** to the 3<sup>rd</sup> round of counselling, and the released seat will be allotted afresh in accordance with merit.
5. The existing schedule for the 3<sup>rd</sup> round and the Mop-up round of counseling vide Public Notice dated 03/06/2020 stands cancelled. **The revised schedule for the 3<sup>rd</sup> Round and the Mop-up Round shall be notified in due course.**
