**PROCEDURE FOR ADMISSION CANCELLATION**

- The candidates, who have confirmed their admission after submitting the original documents at the Help Center, want to cancel the admission, they have to go to the admission reported Help Center, in-person.
- The admission can be cancelled till 4.00 pm on 14.07.2020.
- The same seat will not be available to such candidate for subsequent round of admission but candidates can take part in subsequent round of counseling.
- If candidate cannot come for some reason, the parents/representatives must bring the “Authority Letter” signed by candidate to Help Center. Without Authority Letter, parents/ representatives won’t be able to collect the documents. Authority letter is available on the page 2 of this document.
- The candidates have to submit following documents and then can collect the original documents.
  - Original admission order of ACPPGMEC
  - Self-attested Xerox-copy of Allotment Letter of All India Quota/ Deemed/ Central Universities / DNB/ Other State Counseling OR application of cancellation if not admitted anywhere
  - Authority letter (In case parents/representatives want to collect the documents)
