ORDER
(Date: 9th July, 2020)

1. This appeal is filed requesting grant of 3% increase on the basis of NABL accreditation received by the appellant, after passing of order by this Authority in Appeal No. 125/2019 dated 18th November, 2019.
2. According to the appellant, when this order was passed by this Authority, the NABL accreditation certificate was not received by the appellant.
3. Now, appellant has received letter from National Accreditation Board for Testing and Calibration Laboratories dated 02.07.2020, by which accreditation is granted from 01.07.2020 to 30.06.2022, the issuance of letter is in progress and certificate no. is MC-3448. Because the appellant was not having the certificate, benefit of accreditation could not be given when the order was passed. Subsequently, when the certificate was received by the appellant, he approached the Admission and Fee Regulatory Committee (hereinafter called 'AFRC') for grant of benefit of NABL accreditation. However, the appellant was told by the letter dated 04.07.2020, that Chairman of the Committee had resigned and in his place fresh appointment had been made, but

according to Shri Chaube, meeting of the committee could not be held in near future and it would take time, and in such situation, it was not possible for AFRC to consider grant of benefit for NABL accreditation in near future.

4. The appellant prayed that this Authority may give benefit to the appellant, as fresh session is about to start and it would be proper to inform the amount of fee to be charged by the appellant institution during the next academic session.
5. Shri Alok Chaube, appearing on behalf of AFRC submits that though new Chairman has been appointed and is likely to join shortly, it is not possible to arrange a meeting of AFRC in near future, and therefore, to safeguard interests of the students, it would be better to grant benefit of NABL.
6. I have taken into consideration all the facts and circumstances that arose, due to peculiar situation and of the view, that in this case, basic fee had already been fixed and prayer of the appellant was only for modification in the order. In the light of the subsequent development that is receipt of NABL accreditation by the appellant, there appears to be no harm in considering the prayer of the appellant and grant him the benefit.
7. Shri Kirti Daga, Chartered Accountant attached to AFRC, submitted the calculation sheet by e-mail, which is kept into record. According to the calculation Rs. 32,105/- is to be added to the fee fixed by this Authority in Appeal No. 125/2019 dated 18th November, 2019.
8. Accordingly, this appeal is disposed off by modification in the order passed in Appeal No. 125/2019 dated 18th November, 2019 and after giving benefit for NABL accreditation the fee fixed by this Authority in aforesaid appeal for MD/MS(Clinical) is raised from Rs. 13,40,000/- per student per year to Rs. 13,72,105/- per student per year. Other

conditions and charges fixed by aforesaid order shall remain unchanged.

The appeal stands disposed off.
