- Subject: Schedule for the 2<sup>nd</sup> Round of DNB Counseling for admission to Sponsored DNB seats (Post MBBS and Post Diploma- 2020 Admission Session) and submission of Undertaking and NOC by the applicant candidates. Refer Public Notices dated 10-06-2020, 30-06-2020, 15-07-2020, 23-07-2020, 14-08-2020 and 21-08-2020.
  - 1. The **2<sup>nd</sup> Round** of Online Centralized Merit Based counseling for admission to Sponsored DNB seats (Post MBBS and Post Diploma) for 2020 Admission Session shall be conducted by NBE as per the schedule given below:

iv.	Payment of the First Year Course Fee	6 <sup>th</sup> - 9 <sup>th</sup> September, 2020
٧.	Physical Joining at the allotted institute	6 <sup>th</sup> - 15 <sup>th</sup> September, 2020

- 2. The 2<sup>nd</sup> round shall be the final round and no round of counseling shall be held by NBE thereafter for the sponsored seats. The seat matrix of the Sponsored seats for the 2<sup>nd</sup> round shall be available on NBE website <u>http://cns.natboard.edu.in/</u>
- Candidates who could not participate in the 1<sup>st</sup> Round of counseling due to non- submission of the Undertaking and NOC are required to upload their Undertaking and NOC in the prescribed format (as available on website) on <u>http://cns.natboard.edu.in/</u>
- 4. Candidates who had submitted Undertaking and/or NOC that were not in accordance with the prescribed format, or had submitted them after the last date, are required to upload their Undertaking and NOC afresh in the prescribed format (as available on website) on <u>http://cns.natboard.edu.in/</u>
- 5. The last date for submission of the Undertaking and NOC as aforesaid is 31.08.2020. All candidates who wish to participate in the 2<sup>nd</sup> Round of counseling must ensure that their Undertaking and NOC is submitted before the last date i.e. 31.08.2020 failing which they shall ineligible for participating in the 2<sup>nd</sup> round of counseling.
- **6.** The last date for physical joining for the 1<sup>st</sup> round is 31/08/2020 and no relaxation shall be given for the same. Candidates who fail to undertake physical joining by 31/08/2020 shall lose their allotted seat and the fee deposited by them shall be forfeited. Candidates who have Freezed their allotted seat in the 1<sup>st</sup> Round by paying the 1<sup>st</sup> year course fee shall not be allowed to participate in the 2<sup>nd</sup> Round of counseling for sponsored seats.
- **7.** Candidates may note that the allotment of seat in the counseling is subject to the candidates being eligible in all respects and verification of their original documents at the time of joining the allotted institute.
