Candidates who have completed CRRI or will be completing CRRI before Counseling of AIAPGET starts are alone eligible to apply for Post Graduate Degree Course in Homoeopathy. 17	<p><b>DECLARATION OF MERIT LIST</b></p> <p>On receipt of AIAPGET 2020 (HOMOEOPATHY) common merit list declared by MoA / AIAPGET Secretariat, the marks scored by the candidates for a maximum of 100 will be computed to a maximum of 90 marks up to Two Decimals for the purpose of arriving State Merit list.</p>
18	<p>Experience marks will be calculated for each applicant in the following method. One (1) mark for each completed year after the completion of CRRI shall be awarded as Marks for Experience up to a maximum of TEN marks as on 31-08-2020. Fractional values of a year will not be counted for awarding marks for Experience.</p>
