# ORDER

- 1. Whereas, complainant Dr. Gopal Murlidhar Soni (The Secretary, Buldhana District Pathology Association) has filed complaint to take legal action against Dr Ashok Shrawan Bawaskar (Respondent) who is referring patient to clinical laboratory run by DMLT's &/or signs DMLT Reports, given space to DMLT's for running laboratory/pathology. Thus, promoting, protecting & patronizing quackery in medical field. Further, boosting moral of quack & associate professionally with a person who violates various acts related to medical practice.
- Therefore, in view of Section 22 of MMC Act, 1965 and Rules 62-74 of MMC Rules, 1967 Council has decided to conduct enquiry and issued letter dt. 20/06/2018 to submit explanation from Dr. Ashok Shrawan Bawaskar (Respondent).
- 3. Dr. Ashok Shrawan Bawaskar (Respondent) has submitted his explanation vide letter dt. 02/07/2018.
- 4. Council has forwarded explanation received from Dr. Ashok Shrawan Bawaskar (Respondent) to complainant Dr. Gopal Murlidhar Soni (The Secretary, Buldhana District Pathology Association) on 16/02/2019.
- Complainant Dr. Gopal Murlidhar Soni (The Secretary, Buldhana District Pathology Association) has filed rejoinder on 15/03/2019.
- 6. All the documents including explanation of Dr. Ashok Shrawan Bawaskar (Respondent) referred to Ethical Committee.
- 7. Ethical Committee has decided to call both the parties for hearing. Thereafter,

- summons issued on dt. 22/03/2019 for the enquiry dt. 30/03/2019.
- 8. After scrutiny of complaint papers and hearing of both the parties Ethical Committee has consider complaint and observed that;
  - a. Dr. Ashok Shrawan Bawaskar (Respondent) is running in-house laboratory/pathology run by DMLT technicians.
  - b. Secondly, Dr. Ashok Shrawan Bawaskar (Respondent) is referring patient to clinical laboratory run by DMLT's.
  - c. Treats the patient on the basis of reports issued by DMLT technicinas.
- 9. In view of above reasons the Ethical Committee in its meeting dt. 30/03/2019 has decided to frame charges against Dr. Ashok Shrawan Bawaskar (Respondent). Accordingly, on 10/10/2019 charge sheet including statement of allegation, relevant papers provided to Dr. Ashok Shrawan Bawaskar (Respondent).
- Dr. Ashok Shrawan Bawaskar (Respondent) has filed reply on notice of charges on 31/10/2019.
- 11. Council vide letter dt. 09/10/2020 issued summons to complainant Dr. Gopal Murlidhar Soni (The Secretary, Buldhana District Pathology Association) as well as Dr. Ashok Shrawan Bawaskar (Respondent) to appear for enquiry before Executive Committee through video conference (Zoom App) to state their case on 23/10/2020.
- 12. On the day of hearing i.e. on 23/10/2020, complainant namely Dr. Gopal Murlidhar Soni (The Secretary, Buldhana District Pathology Association) along with his advocate Sandip Purohit and Dr. Ashok Shrawan Bawaskar (Respondent) were present.
- 13. Complainant Dr. Gopal Murlidhar Soni (The Secretary, Buldhana District Pathology Association) and Dr. Ashok Shrawan Bawaskar (Respondent) have stated their case.
- 14. Committee observed that, despite of having 5 qualified pathologists in Khamgaon Dr. Ashok Shrawan Bawaskar (Respondent) used to send patients to DMLT path labs for investigations & further, misguided the Council by saying he is unaware of the Supreme Court order which is applicable to each and every doctor in respect of DMLT. Further, RMP accepted his guilt that he is treating the patient on the basis of technician's report. Secondly, evidence shows that technician also running laboratory in his premises.
- 15. Thus, for the gross violation of professional misconduct and code of ethics as enumerated under Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulation 2002, r/w section 22 of MMC Act. 1965 and charged under article 1.1.1, 1.1.2, 1.2.1, 1.9 of chapter 1 of Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulation 2002 as well as failed to maintain the dignity of the profession. Thus, failed to observe the law of the country in regulating practice of medicine. Also failed to observe the provisions of the state & violated the guidelines of Apex Court in the subject.

- 16. Thus, aforesaid conduct of Dr. Ashok Shrawan Bawaskar (Respondent) is highly objectionable in medical fraternity. Therefore, you are negligent & involved in gross professional misconduct.
- 17. Therefore, the Council has sentenced to remove the Registration No.-62971 of Dr. Ashok Shrawan Bawaskar (Respondent). for 2 months from Register of the Council from the date of the order. The said punishment of removal of registration shall be implemented after appeal period are over.
- 18. "A medical practitioner or professional who is aggrieved by any action taken by a State Medical Council may prefer an appeal to the Ethics and Medical Registration Board against such action as per Section 30 (3) of the National Medical Commission Act, 2019 to NMC."

Date of order shall be treated for the Period of limitations.
