INSTRUCTIONS

- ❖ **Don't share your login id, OTP and password with others**
- ❖ **Since this is mop up counselling, if any PG seat allotted to the candidate according to their choice filling, they should join without fail. If any candidate who is allotted and not joined in this mop up counselling, he/she will not be**

allowed to participate in Stray Vacancy Round and will also have to pay the penalty.

❖ **For P.G. Degree Course Rs.15 lakh.**

❖ **For P.G. Diploma Course Rs.10 lakh.**

❖ **The candidates who are willing to participate in this counselling have to Register.**

❖ Candidates participating by ONLINE COUNSELLING for PG DEGREE/ DIPLOMA course will have to remit a non-refundable amount of Rs . 1000/- as processing fee through online by using a Debit Card /Net Banking or Credit Card. The candidates who have already paid processing fee need not pay again.

❖ Candidates should pay as Security Deposit of Rs.2,00,000/- through online via net banking. The candidates who have already paid Security Deposit need not pay again.

❖ Only Candidates registered and filled their choices in Mop up round will be eligible for stray vacancy round if they are **Not allotted** in the Mop up Round. Hence candidates who wish to participate in stray vacancy round are instructed to register in mop up round

❖ Vacancy position for the courses will be available on official websites.

❖ Selection Committee does not take responsibility for any Connectivity error.

Eligibility Criteria

❖ The candidates who have applied and are now eligible after lowering of percentile.

❖ The candidates who have not been allotted in Round I and Round II Counselling.

❖ The candidates who have been allotted, but not joined in Round I & Round II of State Quota and All India Quota are eligible to participate in this counselling.

❖ The candidates who have been allotted, but discontinued in stipulated time in Round I of AIQ / State Quota are eligible to participate in this counselling.

Non Eligibility Criteria

❖ **As per the directions of Hon'ble Supreme Court of India in W.P.(c) 267/2017 DAR-US-SLAM EDUCATIONAL TRUST and Ors. Vs. MEDICAL COUNCIL OF INDIA and Ors. Dated 09-05-2017, the candidates joined in All India Quota Round II counselling are not allowed to vacate the seat. On similar ground the candidates who have joined in Round II of State counselling will not be permitted to vacate/resign/surrender the seat.**

❖ **The candidates who have taken admission in second round of allotment or carry the seat allotted in first round beyond notified date, which is not upgraded in second round, will not be permitted to vacate the seat.**

➤ The candidates who fall into these above categories are not eligible to participate in mop up / subsequent round of counselling.

➤ The candidates who have been allotted in mop up round of All India Quota/Deemed university/DNB (conducted by NBE) are **not eligible to participate in state mop up counselling and Stray Vacancy round.**

❖ **In order to prevent the seat blocking:**

If a candidate is getting an allotment under government /government quota in Self financing colleges in mop up counselling, he/she cannot claim a seat in this Management mop up counselling. Hence candidates are instructed to choice lock carefully.

Conversion of seats in Mop Up Round

❖ **If there are no eligible NRI/Minority candidates opting for PG Degree/Diploma courses, the same will be allotted for general Management category candidates.**

❖ Selection of candidates to PG DEGREE/ DIPLOMA course shall be made by the ONLINE COUNSELLING on the basis of NEET PG Rank.

❖ Candidates selected for admission should give a self-declaration form at the time of the reporting to the concerned Medical College that he / she is liable for forfeiture of selection / admission and liable for criminal action if suppression of facts and/or mis-interpretation is found at any time during or after the admission to the course.

❖ Candidates should pay the tuition fee online and then download their provisional allotment order and join the course in the concerned Medical Colleges on or before the date and time stipulated during this phase of ONLINE COUNSELING.

❖ The candidates should produce the following original certificates in person

at the time of joining in their selected Medical College along with the scanned copy of original certificates to the concerned College.

- a) NEET PG-2022-Score Card.
- b) NEET PG-2022 Admit Card.
- c) Aadhar Card
- d) MBBS Degree Certificate or Provisional Pass Certificate and Diploma certificate.
- e) CRRI Completion Certificate.
- f) Permanent Medical Registration Certificate issued by the Medical Council of India / State Medical Council or Provisional Registration Certificate issued by the Medical Council of India / State Medical Council.
- g) Eligibility Certificate, if applicable.
- h) A copy of receipt of payment of Tuition fee.
- i) Post Card size color photograph (4"x6") the same photo that has been uploaded in NEET PG-2022.

❖ Candidates who are seeking admission under Minority Category should produce the following documents along with the above original certificates:

- Minority Certificate
- Nativity certificate of the candidate
- Community certificate of the parent (Not applicable for forward community)
- Study certificate of the parent

❖ Candidates who are seeking admission under NRI Category should produce the following documents along with the above original certificates:

- NRI status of the financial supporter issued by the Indian Embassy of the respective country under their seal.
- Certificate of Relationship between the NRI financial supporter and the candidate issued by the competent authority and valid Indian Passport of the NRI financial supporter.
- NRE (Non Resident External) Bank Account Pass Book of the financial supporter.
- Evidence for payment of Development charges US \$1000/- to the college by the NRI financial supporter (Onetime payment at the time of admission only).
