**WB PG Medical and Dental 2022 Round 2 Notice**

The WB PG Medical and Dental 2022 Round 2 counseling shall start from 19/10/2022 onwards.

The eligible candidate who paid fee during Round 1 but failed to appear for verification, can download the acknowledgement letter (the acknowledgement letter may show date and time of Round 1 schedule as it was in round 1 when the candidate paid fee, but they can appear in the same venue as mentioned in the said acknowledgement letter) and can appear for verification.

The cut off for **NEET MDS 2022 is reduced by NBEMS vide their public notice dated 14-10-2022** and such candidates who are now eligible due to revised cut off can participate in this Round 2 counseling.

The candidate who was allotted in Round 1 and got admitted in Round 1 and opted for Round 2, if they do not fill choice during round 2, their earlier seat of Round 1 shall remain intact.

The candidate who was allotted in Round 1 and got admitted in Round 1 and opted for Round 2, if they fill choice during round 2, but no allotment is received in Round 2, and then also the earlier admitted seat in Round 1 shall remain intact.

The candidates, who are listed in the final eligible list for Round 2, can provide choice for Round 2 counseling. **Fresh choice filling is needed for allotment.** If eligible and listed candidate do not fill fresh choice, then he/she shall not be considered for allotment.

**The candidates, who have already verified in Round 1, are not required to attend for verification again.**

The candidates who are allotted private medical college or private dental college like KPC Medical College/IQ City Medical College/ICARE Haldia/JIMS Budge Budge/GIMSH Durgapur/GNIDSR Panihati/HIDSAR Haldia; are advised to attend the admission kiosk of the above stated hospitals that shall be set up at the premises of Calcutta National Medical College Kolkata during admission schedule like Round 1.

Few candidates in Medical and Dental have requested for **initialization of their data through nodal officers at verification venues in Round 1**. Such candidates after initialization by the system shall be able to login and apply fresh with payment of fees as all their earlier data from system shall be erased.

Round 1 not reported candidates may also participate and fill choice in Round 2.

There is a concept of Relieving letter for the candidates who were admitted in Round 1, then provided willingness for Round 2, filled up fresh choice in Round 2 and now got allotted in Round 2. The candidate has to release documents and fee from previously admitted college, get server generated relieving letter from that college and then to move to newly allotted college for admission. All these have to be done within the time schedule of admission for Round 2.

The candidate who were admitted in Round 1, not provided willingness for Round 2, shall retain in their Round 1 seat as it is and at the end of Round 2, shall be considered as remaining admitted in same seat after Round 2.

The candidate who gets new allotment in Round 2, if admits in that seat, then after Round 2 admission process is over shall be considered to be remaining in that seat of Round 2.

**After the completion of the admission process of Round 2, the data of the remaining admitted/ retained candidates shall be shared with Govt of India counseling authority and such list shall be out of further round/s of Counseling.**

If a candidate does not report to his/her allotted seat of Round 2, then such candidate may be allowed for Mop Up Round as not retaining any

seat in WB PG 2022 counseling only if such candidate is also not retaining any seat in All India PG counseling 2022 as well. Such candidate can only participate in centralized mop up if pays the counseling fee once again as penalty of not reporting.

The details of eligibility for round 2, the documents needed for verification and admission etc are already stated in earlier notices published in the counseling website [www.wbmcc.nic.in](http://www.wbmcc.nic.in) and the candidates are requested to go through them for reference. They may also contact the Help Centre, the contact detail of which is also provided in the same website as stated above.
