Consequent upon issuance of counselling schedule for conduct of Special Stray Vacancy Round for admission to MD/MS/PGD courses - 2023 by the Medical Counselling Committee (MCC) Government of India vide Notice No. U-12021/02/2023-MEC (Pt.II) Dated: 15-11-2023 and in pursuance of Notification No. 095-BOPEE of 2023 dated 15.10.2023, it is hereby notified for information of all the concerned candidates that the Board shall conduct Special Stray Vacancy Round on 25.11.2023 for admission to MD/MS/PGD Courses - 2023 in Government/Private Colleges/Institutions of UT of J&K for the seats which have remained unfilled or received as shortfall/resignations after conclusion of Mop Up Round of counselling for admission to MD/MS/PGD courses - 2023 conducted by the Board on 14.10.2023 as per the following schedule:-

**Note-I:**

The following procedure shall be followed during conduct of Special Stray Vacancy Round of physical counselling.

1. It is enjoined upon all the eligible candidates that they shall visit/attend counselling only after checking the Seat Matrix available on the official website of the Board.
2. As notified by MCC in the notice dated 15.11.2023, the candidates who are not holding any seat either in All India Quota (AIQ) or State Quota are eligible to

- participate in Special Stray Vacancy Round. However, candidates who did not join their seats allotted through MCC Round - 3 on wards are “Not Eligible” to participate.
3. It has also been notified by the MCC that the Special Stray Vacancy Round is not an upgradation round. Joined candidates of earlier rounds will not be given chance of upgradation.
  4. The candidates who have not been allotted any seat or remained absent during 1<sup>st</sup>, 2<sup>nd</sup> / Mop up Round of counselling shall be eligible to participate in this round of counselling.
  5. The candidates who are participating for the first time in the counselling shall have to pay non-refundable counselling fee of Rs. 2000/- physically, through POS machines kept available at BOPEE offices Jammu/Srinagar on the day of counselling.
  6. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reason beyond its control.
  7. The seat matrix for Special Stray Vacancy Round shall be uploaded on the website of the Board before the date/day of counselling.

The other terms and conditions shall remain the same as notified by the MCC/JKBOPEE from time to time in this regard.
