The counselling for admission to Post Graduate Medical / Dental Degree (M.D. / M.S. / M.D.S.) courses for the year 2023-24 will be done by **CENTAC**.

The candidate seeking admission must apply online through **CENTAC** website ([www.centacpuducherry.in](http://www.centacpuducherry.in)) as per the schedule notified. Registration after the due date will not be entertained.

The candidate shall comply with all the instructions while filling in the application form.

Admission is based on **PG NEET (MEDICAL) / NEET – MDS (DENTAL) 2023** score only and reservation criteria of Government of Puducherry.

The candidate must have passed final M.B.B.S. examination (for MD/MS Course) and BDS examination (for MDS Course) from the recognized Institution/University and **must have completed satisfactorily one year compulsory rotating internship as on 30.06.2023\* (for MD/MS Course) and 31.03.2023\* (for MDS Course)** and must submit their internship completion certificate at the time of admission.

Please note that the candidature is subject to fulfilling the minimum eligibility requirements prescribed for applying to the concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate's own risk and cost and if at any stage, it is found that if the minimum eligibility requirements are not fulfilled, the admission if granted, shall be cancelled ipso facto and the fees paid, if any, shall not be refunded in any case.

CENTAC will carry out only the allotment of the seats. The admission is subject to the approval of The National Medical Commission / The Dental Council of India (DCI) and the Pondicherry University as per the norms.

The various terms and conditions mentioned in the Bulletin of Information are subject to the change made in the rules and regulations by the Government of Puducherry, affiliating University from time to time as per the decision of the Academic Council/ Executive Council and also binding regulations/ directions of the Ministry of Health & Family Welfare (Government of India) and/or National Medical Commission / DCI. CENTAC reserves the right to revise, amend, update, or delete any part of this brochure, as and when considered necessary.

## 1. INTRODUCTION

The counselling for allotment of candidates to Post Graduate Medical / Dental Degree (M.D. / M.S. / M.D.S.) courses for the year 2023-24 will be done by **CENTAC**.

CENTAC will conduct counseling for allotment of candidates to Post Graduate Medical / Dental courses for seats available in **Government Colleges, Government Quota** seats in Private Colleges, **Management Quota, Linguistic (Telugu) Minority and Religious (Christian) Minority Quota seats** in Private Colleges and **NRI** seat in PG Dental (M.D.S.) in Mahatma Gandhi Post Graduate Institute of Dental Sciences, Puducherry.

Allotment is based on **PG NEET (MEDICAL) / NEET – MDS (DENTAL) 2023** score only.

The candidate must have passed final M.B.B.S. examination (for MD/MS Course) and BDS examination (for MDS Course) from the recognized Institution/University and **must have completed satisfactorily one year compulsory rotating internship as on 30.06.2023\* (for MD/MS Course) and 31.03.2023\* (for MDS Course)** and must submit their internship completion certificate at the time of admission.

### 4. ALLOTMENT PROCEDURE

Candidates seeking allotment to Post Graduate Medical / Dental Degree Courses in Government Colleges, Government Quota seats in Private Colleges, Management Quota seats and Minority Quota seats (Telugu & Christian) in Private Colleges and one NRI seat in PG Dental course should apply Online through the CENTAC website.

1. **Application must be submitted online only through the website [www.centacpuducherry.in](http://www.centacpuducherry.in)**

2. Before filling the application, the candidate should read the Information Brochure available in CENTAC website carefully.
3. The Information Brochure 2023-24 may be downloaded for ready reference from CENTAC website from **30.05.2023 (Tuesday)** onwards.
4. The last date for applying online is **13.06.2023 (Tuesday), 6:00 pm**.
5. The candidates should ensure the following:
  - 5.1. Upload **recently renewed, scanned, self-attested photo copies of certificates**. Original certificates must be produced only at the time of **admission in the respective colleges**.
  - 5.2. All certificates produced in support of various claims such as Residence, Community, Freedom Fighter (FF), Ex-serviceman (ESM), Persons with Disability (PwD) & Meritorious Sports Persons (MSP), Christian / Linguistic Minority, NRI, etc., should be valid and obtained from the respective competent authorities.
  - 5.3. Residence and Community certificates issued by the Revenue Department, Govt. of Puducherry alone will be considered for claiming reservation benefits under Government / Christian / Linguistic Minority quota.
  - 5.4. Sports certificates must be countersigned by the concerned authorities.
6. Candidate should register and login to fill in all their details. Only on payment of application fee, the candidate will be allowed to enter his/her preferences of courses. Without filling the course preferences, the application will not be considered for allotment of seats. Candidate should bear in mind that the allotment of seats will be made based on the order of courses he/she has given as preference, subject to the availability, as per merit and reservation.
7. The candidate is advised to give as many choices of courses for which he/she is eligible in as many colleges as they wish. If a choice of course or college is not made, it will be deemed that he/she is not interested in the particular course or college.
8. The candidate should give their prioritization of course preferences in each round and the last date for submission will be published in CENTAC website. The candidate will not be able to edit his course preference after the last date. However, CENTAC reserves the right to permit all the candidates to alter their preferences, if required. The decision taken will be duly intimated to candidate from time to time.
9. Details about Courses and Number of seats in the colleges will be published in CENTAC website after the approval of the concerned competent authorities of the Government of Puducherry. The seat

matrix and fee structure will be published in CENTAC website after receiving the same from the concerned department of the Government of Puducherry.

10. Claim exercised with regard to Residence/ Community/ Special category are subject to verification of the submitted documents and cannot be changed once the **FINAL merit list is published**. However, CENTAC reserves the right to update the merit list in case of genuine claims supported by documentary evidences.
11. On verification of the candidates' credentials, the Draft Merit List will be published. Adequate time will be given to raise objections and submit documents, if any, and subsequently, the Final Merit List will be published.

Separate Merit Lists will be published for Government Quota Seats, Management Quota, Christian and Linguistic Minority Quota Seats. The candidate should refer to the CENTAC website [www.centacpuducherry.in](http://www.centacpuducherry.in) for the merit list.

12. Only **computer-based online allotment** will be done in Round I and in Round II. Physical counseling or online counseling might be done in the event of a mop up round.

For allotment of Government quota, vertical reservation will be implemented first and later horizontal reservation, if any, to the extent needed will be done.

13. Once the Provisional allotment list is published, the candidate must download the **Provisional Allotment Order** and report to the allotted college within the given time. If the candidate does not report within the given time, provisional allotment will be automatically cancelled. Similar procedure will be followed for the subsequent rounds of allotment as well.
14. **Sliding:** Sliding will be allowed in Round 1 and Round 2 only. No sliding will be allowed during Mop-up round and Stray counselling round. So, Candidates joined upto Round 2 will not be allowed to vacate the seats.

As per NMC guidelines,

The candidates who have joined a seat in Round 2 of State quota counselling or AIQ counselling will not be eligible for the further rounds of counselling. Vide order dated 31/03/2022 the Hon'ble Supreme Court of India in W.P. No. 174 of 2022 issued directions which are as follows:

“(v) In line with the regulations which have been notified on 5 April 2018, students who have joined in round 2 of the state quota or round 2 of the AIQ shall not be eligible to participate in the mop-up round for All India Quota.”



15. **Enabling Provision:** If all the students of a specified category have been admitted, and even thereafter, if any seat remains vacant for that specified category, the same will be de-reserved as per the guidelines.
16. The candidate will be informed of all the proceedings of CENTAC through SMS / E-mail. The same will also be published in the CENTAC website and in the public media by way of press releases. After the online application is opened the students should refer to the CENTAC website [www.centacpuducherry.in](http://www.centacpuducherry.in) regularly, for updates.
17. The final authority to settle disputes, if any, in any matter will be the Chairman, CENTAC.
18. **STUDENTS ADMITTED THROUGH CENTRALISED ADMISSION COMMITTEE (CENTAC) UNDER “GOVERNMENT QUOTA SEATS” TO PROFESSIONAL COLLEGES OF THIS UNION TERRITORY, IN ANY PARTICULAR ACADEMIC YEAR WILL NOT BE ELIGIBLE FOR ANY GOVERNMENT QUOTA SEATS IN THE SUBSEQUENT YEARS.** (G.O. Ms. No. 60, Puducherry, dated 12.10.2015 of the Chief Secretariat, (Hr. & Tech. Edn.), Puducherry.

## 5. STEPS FOR FILLING UP THE APPLICATION

1. All the candidates seeking admission to the Post-graduate Medical (MD / MS/ MDS)/Dental courses are required to apply online on website [www.centacpuducherry.in](http://www.centacpuducherry.in).
2. As a first time user, candidate shall create the login details as per the following steps:-
  - On the “New Registration” page, candidate has to enter a valid Mobile Number and Email ID which would be used for any future communication for admission purpose. The candidate should take utmost care in providing the Mobile Number and Email ID, as all communications from CENTAC will be sent to the same.
  - Candidate shall then create a new password (of maximum six characters) for online registration purpose. This password need not be the same as candidate’s email account password, which is used to access one’s email account.
  - Candidate shall provide a valid mobile phone number (10 digit number without any prefix).
  - Please verify that all the details given in the form are correct. This information will be used during the entire admission process. No change/modification will be allowed. Please be careful in filling up the required information in all aspect.
3. After successful registration the applicant shall login by using their “registered email-id” and “password” to fill the online application form.
4. Fill all the details in the application form.
5. Applicant shall upload the following documents (wherever necessary):-

- i. Passport size photograph of the applicant (20 to 50 KB)
- ii. Scanned signature of the applicant (20 to 50 KB)
- iii. Self attested copy of High School/Higher Secondary Certificate/Birth Certificate for verification of date of birth (100 to 500 KB).
- iv. Self attested copy of certificate in support of educational qualifications: MBBS Degree/BDS Degree as per requirement of the course (100 to 500 KB).
- v. Self attested copy of Residence / Community / EWS / Freedom Fighter / Ex-Serviceman/ Person with Disabilities/Sports certificates, if applicable (100 to 500 KB).
- vi. Self attested copy of Admit Card of NEET-PG/NEET-MDS-2023 (100 to 500 KB).
- vii. Self attested copy of Score card of NEET-PG/NEET-MDS-2023(100 to 500 KB).

**Note:** The candidates are required to bring Printout of Application Form, Allotment letter and Original Certificates along with self attested photocopies of all the required documents at the time of Admission.

6. Once all the above-mentioned files are uploaded, applicant can proceed with “Make Payment”. Applicant can also update the uploaded files and application form using “Back button” before making payment. Once payment is made, no changes can be made in the application.

7. The application submission process shall be completed only after making payment of the online application fee by the candidate.

9. Please note that the candidature is subject to the candidate fulfilling the minimum eligibility requirements prescribed for applying to the concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate’s own risk and cost, and if at any stage, it is found that the minimum eligibility requirements are not fulfilled, the seat allotted shall be cancelled ipso facto and the fees paid, if any, shall not be refunded in any case. Once the payment is made for the Application form, corrections, additions, deletions etc. in any manner shall NOT be allowed. The candidates are, therefore, advised to fill their forms carefully.

10. The candidate shall comply with all the instructions while filling in the application form.

## 6. ELIGIBILITY CRITERIA

Eligibility Criteria for admission to Post Graduate Degree MD / MS / MDS Courses:

a. The candidate must have passed final M.B.B.S. examination (for MD/MS) and BDS examination (for MDS Course) from any recognized Institution / University and must have completed satisfactorily **one year compulsory rotating internship as on 30.06.2023\* (for MD/MS Course) and 31.03.2023\* (for MDS Course)** and must submit their internship completion certificate at the time of admission.

\* Refer National Board of Examinations in Medical Sciences website <https://nbe.edu.in/> for further instructions.

b. A candidate in order to become eligible for admission must obtain a minimum required percentile in **NEET-PG/NEET-MDS-2023**, as prescribed by regulatory authorities such as National Board of Examination, National Medical Commission, Ministry of Health and Family Welfare, etc. as the case may be.

### NOT ELIGIBLE (Refer NBE website)

A candidate who has joined a Post Graduate Degree course in any branch and discontinued the course on any grounds after the cutoff date fixed by the National Medical Commission are not eligible to apply for two subsequent academic years.

A candidate who took an allotment for PG Degree course in any branch in the final phase of counseling and not joined the course on or before the cutoff date, his/her eligibility to apply for subsequent year is as per guidelines of the competent authorities of Government of Puducherry.

A candidate who is undergoing a Post Graduate Degree course is not eligible to apply for any Post Graduate Degree.

A candidate who is completing a Diploma Course (including All India Quota) is not eligible to apply for any Post Graduate Degree Courses in the same academic year.

A candidate with a Post Graduate Degree is not eligible to apply for admission to any other Post Graduate Degree Course. However, a candidate who is a Diploma holder is eligible to apply for Post Graduate Degree Course.

## 7. CLASSIFICATION OF SEATS

SNO	CATEGORY	Eligible Candidates
1	Government Quota	As per U.T. Govt. norms, only Residents of the U.T. of Puducherry are eligible.
2	Management Quota	No restriction on Residence. Filled on All-India basis.

3	Management Quota – Christian Minority	Students who are Christians and Residents of the UT of Puducherry only are eligible.
4	Management Quota – Telugu Minority	Students with Telugu as Mother Tongue and residents of the U.T. of Puducherry only are eligible.
5	NRI (PG Dental only)	All NRI / NRI Wards / NRI Sponsored / PIO / OCI candidates and Foreign Nationals

### **For Minority Quota Seats in Private Medical / Dental Colleges**

(i) For **Minority Quota seats in Minority Medical / Dental Colleges** candidates who are **residents of the U.T. of Puducherry and belonging to respective minorities are only eligible**, i.e., for the minority quota seats in PIMS, candidates who are resident of U.T. of Puducherry and belonging to **Christian religious minority** alone are eligible. For the minority quota seats in SVMCH&RC, candidates who are resident of the U.T. of Puducherry and belonging to **Telugu linguistic minority** alone are eligible. The details of these seats and the fee structure will be notified by the Health Department. Candidates are advised to check the CENTAC website for updates on these.

(ii) U.T. of Puducherry candidates claiming seats under **Christian Minority Quota** should produce valid proof like Transfer Certificate or Community Certificate to prove his/her religion is **CHRISTIANITY**. If CHRISTIANITY is not mentioned in TC or Community Certificate, attach certificate as per Annexure – VII.

(iii) U.T. of Puducherry candidates claiming seats under Telugu Minority Quota should produce valid proof like Transfer Certificate or Certificate/letter from the school last studied stating that his/her mother tongue is **TELUGU as per the school admission records**. If Mother Tongue TELUGU is not mentioned in TC, attach certificate as per Annexure - VIII.

(iv) **Conversion of Minority Quota seats into General Management Quota seats:**

In case these minority quota seats are not filled in the Second round of Counselling, then these unfilled seats will be converted to general management quota seats and filled on All India basis during Round 2 itself.

After exhausting the entire Minority merit list of candidates, the unfilled Minority seats will be converted into All India Management seats and operated in Round 2 as per the directions of the Health department.

The course preferences for PG NEET **MD / MS / MDS** Management quota seats in Minority institutions, will be enabled in Round 2 and will be operated after converting unfilled seats in Minority quota seats in Round 2 itself.

**Note:** In Round 1, **MD / MS / MDS** Management quota seats for Minority Institutions will not be enabled for PIMS, Puducherry (Christian Minority) & SVMCH&RC, Puducherry (TELUGU Minority).

### **For NRI /NRI ward/OCI /PIO/Foreign Nationals Candidates**

Candidates seeking admission has obtained BDS degree in a Medical or Dental in recognized institutions which should be approved by MCI / DCI. For claiming NRI/ NRI Ward / NRI Sponsored / OCI / PIO / Foreign Nationals, candidates should submit the following certificates, whatever applicable.

- i. Candidate's parents resident certificate issued by the Embassy of that country complying with the Income Tax Rules / any other certificates to establish evidence that they are resident of that country / affidavit on Rs.100/- e-stamp paper to that effect.
- ii. Candidate's passport / VISA / Resident VISA.
- iii. Citizenship of the candidate.
- iv. Income Tax Documents required as per the Income Tax Act 1961. (If applicable)
- v. If NRI Sponsored – with NRI Sponsor’s acceptance certificate. (If applicable)
- vi. If candidate is foreign medical graduate must submit screening test certificate.
- vii. Candidate’s Study certificate for having studied outside India where applicable for the qualifying examination.

**Note:** For the purpose of verification e-document may be considered with regard to NRI ward certificate subject to submitting the original at the time of taking the admission.

## **8. MODE OF RESERVATION (Applicable for Seats in Govt. Colleges and Govt. Quota Seats in Private Colleges in the U.T. of Puducherry)**

The Mode of Reservation while allotting the seats will be as follows:

- All the candidates should be Indian National and Residents of Puducherry.
- Vertical Reservation First - General, EWS, OBC, MBC, EBC, BCM, SC, ST, BT.
- Horizontal / Special Reservation – FF / ESM / PwD / Sports will be done if adequate seats are not filled after fixing vertical reservation, i.e., if the requisite seats are not filled while doing vertical reservation, the last candidate in the respective category will be replaced as per merit.

## 9. NATIONALITY CRITERIA

A candidate seeking admission through CENTAC should be an Indian National. However, French Nationals residing in the UT of Puducherry and covered by the terms of the Treaty of Cession shall be treated on par with Indian Nationals, for the purpose of admission to all the courses.

## 10. RESIDENCE CRITERIA

Reservation of PG seats shall be as per the norms of the Government of Puducherry. (G.O. Ms. No. 64 Dated 25/05/2006, Chief Secretariat (Edn. I)).

An applicant is considered to be a Puducherry resident if he/she is an **Indian National** and satisfies at least one of the following criteria:

- i) The candidate or whose parent (either Mother or Father or Both) or Guardian (in case of children who have lost both the parents) has been residing continuously in this Union Territory for at least five years preceding the date of application. (Refer Annexure I-1).
- ii) Those who have passed the SSLC / HSC or any other public examination and for that purpose had undergone academic studies continuously **for 5 successive classes immediately preceding the qualifying examination** (including the year of qualifying examination) in a recognized educational institution located in Pondicherry UT and having their residence in Pondicherry UT for 5 years continuously during that period. **Mere stay in places such as residential hostel would not amount to residence.** (Attach certificated as per Annexure I-2a & 2b).
- iii) Children of natives of U.T. of Puducherry who have declared any place in U.T. of Puducherry as their home town and so certified by their respective Heads of Office. Nativity Certificate in the prescribed format has to be enclosed. (G.O. Ms. No. 64 dated 25<sup>th</sup> May 2006).
- iv) a) Children whose parents are Central/ State Government Servants/ Defense Personnel/ Central Paramilitary Forces/ Employees of Public Sector Undertakings wholly or substantially owned either by the Central Government or by the Puducherry Administration posted and serving in U.T. of Puducherry for atleast a minimum continuous period of **three** years immediately prior to the last date of submission of application. (Attach certificate as per Annexure I-3a & 3b)  
  
b) Children of the above said employees should have studied HSc two years in any of the schools in the U.T. of Puducherry and should have passed the qualifying examinations (HSc) from the same school. (G.O. Ms. No. 04, Puducherry dated 09.02.2016 of the Chief Secretariat (Hr. & Tech. Edn.), Puducherry.

- c) Candidates seeking admission to the seats earmarked for the Residence of U.T. of Puducherry shall not claim the benefit of Residence in any other state / U.T. An affidavit / undertaking as provided in the **Annexure – I-A** shall be submitted by the parents / Guardian of the candidate while submitting their application. If it is found later that the candidate has claimed Residence / Nativity in any other state / U.T. then the admission will be liable to be cancelled at any stage. Further, during the course of study, even if it is subsequently found that any candidate had produced a False Nativity / Residence Certificate or given a false undertaking, it will result in Expulsion of the candidate from the course and also initiation of criminal proceedings against the candidate as well as his / her parents as per provision of the Law.
- v) Children of Defence Personnel who were killed or disabled in action and children of Central Government Servants/ Pondicherry U.T. Government Servants/Defence Personnel/ Employees of Public Sector Undertaking wholly or substantially run either by the Central Government or by the Puducherry U.T. Administration who died while in the service in the Puducherry U.T (Attach certificate as per Annexure I-4/5).
- vi) French nationals residing in the Puducherry U.T. and covered by the terms of the “Treaty of Cession” shall be treated on par with the candidates who produce the prescribed Puducherry U.T. Residence Certificate. Such French Nationals will not be required to produce Residence Certificate; instead they should produce a “Certificate of Registration” issued for this purpose by the French Consulate at Puducherry. Children of these French Nationals shall not be considered for admission under the quota of non-resident. (Submit Proof of Residence from French Consulate, Puducherry)

Children of French Nationals under above, shall not be considered for admission under the quota of Non-Resident.

All the above certificates will be scrutinized first by a committee appointed by the Secretary (Revenue), before final merit list is prepared. Tahsildars of various Taluks and Revenue Officers will be the Members of this Committee.

## **11. RESERVATION OF SEATS (Applicable for Seats in Govt. Colleges and Govt. Quota Seats in Private Colleges in the U.T. of Puducherry)**

Reservation in admission to various courses for the candidates of the U.T. of Puducherry belonging to different categories is as given below. Further, OBC / BCM / MBC / EBC / BT /SC /ST candidates are also eligible for selection under Open General category in addition to the reservations made to them.

**1. Scheduled Caste (SC)**

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Caste under “the **Constitution (Pondicherry) Scheduled Castes Order 1964**” dated 05.03.1964, read with “The Constitution (Scheduled Caste) orders (Second Amendment) Act 2002 (Central Act 61 of 2002) and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

**2. Scheduled Tribe (ST)**

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Tribe under “the **THE CONSTITUTION (PUDUCHERRY) SCHEDULED TRIBES ORDER, 2016**” dated 22.12.2016 and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

**3. Other Backward Classes (OBC), Most Backward Classes (MBC), Extreme Backward Classes (EBC), Backward Classes Muslims (BCM) and Backward Tribes (BT)**

Candidates claiming admission under these categories should enclose the recently renewed certificate issued by an Officer of the Department of Revenue and Disaster Management, not below the rank of Deputy Tahsildar.



#### **4. Freedom Fighter (FF)**

Candidates claiming admission under this category should be Children / Grand Children of Freedom Fighters and they should enclose the necessary certificate issued by the Officer-in-charge, Freedom Fighters Cell, Government of Puducherry.

#### **5. Wards of Ex-servicemen (ESM)**

Those who are registered as Ex-servicemen in the Department of Sainik Welfare (DSW), Government of Puducherry and have got an Ex-servicemen / Widow of Ex-servicemen identity card from DSW should enclose the necessary certificate issued by the Director, DSW, Puducherry.

#### **6. Person with Disabilities (PwD)**

For eligibility under the Persons with Disability Quota, locomotor disorder of lower limbs should be between 40% to 80%. For more details, candidates are requested to refer to the BOARD OF GOVERNORS IN SUPERSESSION OF MEDICAL COUNCIL OF INDIA AMENDMENT NOTIFICATION No. MCI-34(41)/2018-Med./170045, dt. 04-02-2019.

The candidates seeking admission to M.D. / M.S. / M.D.S. courses under this category will be required to undergo a second Medical examination by a Medical Board constituted for the purpose by the Director of Health and Family Welfare Service, Puducherry, to ascertain and confirm the nature and extent of physical disability.

Candidates with any other DISABILITY other than the locomotor disability of the lower limb will not be considered for admission into M.D. / M.S. / M.D.S. courses under this special category. Such application will be summarily rejected without any intimation to the candidates.

The certificates must be obtained within **three months** prior to submitting the application for seeking admission under the category. In case the certificate was obtained earlier, the application will be rejected. The medical certificate issued by the District Medical Board of the area concerned for this purpose is subject to the confirmation by the Director of Health and Family Welfare Service.

The decision of the Director of Health and Family Welfare Service, Puducherry, in this regard will be final.

The candidates seeking admission under this category should produce a full size photograph exhibiting the deformity.

- c. Participation / Achievements in sports / games shown in the list alone, immediately preceding **five** years to the year for which admission is sought will be taken into account. National / State Level Championships / Tournaments conducted by Organizations / Federations recognized by Indian Olympic Association / Ministry of Youth Affairs and Sports, New Delhi alone will be considered for award of marks (Recognition by the Indian Olympic Association / Ministry of Youth and Sports, New Delhi should be relevant to the years concerned).
- d. Open / Invitational Tournaments of any kind will not be considered.
- e. For Tennis, achievements of Top 3 players by his/her position in the ranking list published by ATTA based on the ranking rules and the final rankings of the previous 4 years will be awarded marks for achievements and participation (Necessary forms from Associations are to be enclosed).
- f. For Cricket the Annual Official Championship / Tournaments conducted within the country under the auspices of the BCCI at the District / State/ National Level alone will be taken into consideration for that year.

- g. The participation / achievements of candidates with nativity in the Puducherry Union Territory and who represented the Union Territory of Puducherry alone are eligible for marks under the National Category.
- h. Union Territory of Puducherry candidates are eligible to apply for admission under the Sports Quota and candidates of KVS/NVS/CBSE Schools within Puducherry are also eligible for marks.
- i. All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate form /certificates.
- j. No further enclosures of certificates will be entertained after the last date for submission of completed application.
- k. A candidate can utilize the sports quota only once for these admissions.
- l. The relevant attested copies of the certificates issued by the appropriate authorities as detailed in the G.O Ms.53, dt.24.05.2012 are to be submitted along with the application.
- m. A committee constituted to scrutinize the applications received under this category will rank the candidates based on the marks assigned to the certificate enclosed along with the application and the sports merit list will be published in the CENTAC website.

## **12. MERIT LIST**

### **Government Seats and Govt. Quota Seats in Private Medical Colleges**

Merit List will be drawn based on PG-NEET / NEET-MDS 2023 rank, in which Reservation Policy of U.T. of Puducherry will be applied.

### **Management Quota Seats in Private Medical Colleges**

Merit List will be drawn based on PG-NEET / NEET-MDS 2023 rank.

## **13. SEAT MATRIX**

Seat Matrix with details of reservation will be published in the CENTAC website after receiving the same from the Health Department, Puducherry. Please refer the CENTAC website continuously for updates.

## 14. COUNSELLING PROCEDURE

Admission to the PG Medical (MD / MS) courses is based on the **PG-NEET 2023 Rank**.

Admission to the PG Dental (MDS) courses is based on the **NEET-MDS 2023 Rank**.

Round 1 and Round 2 allotment will be Online. Mop up and Stray vacancy Counselling can be either Online or Offline. CENTAC reserves the right to do either Online or Offline counselling based on necessity.

Online allotment will be done based on the candidate's course preferences, category of seats, reservation and NEET Rank.

Both Round 1 and Round 2 allotment is based on the course preferences submitted by the candidates before the last date for updating the course preferences. If the course preferences are empty, then allotment will not be done.

For Round 2, candidates should submit their willingness and pay the prescribed Registration Fees (only for PG Medical courses) before submitting their course preferences.

After publishing the provisional allotment list, allotted candidates should download the Allotment Order from the dashboard using their Login credentials.

Allotted candidates will be instructed to report to the college with the copy of the Application form, Provisional Allotment Order and all other original certificates within the scheduled date and time.

After verification of the originals and payment of fees, colleges will confirm the provisional admission of the candidates and issue the Admission slip to the candidate.

**Mopup and Stray Vacancy Counselling** – Detailed Guidelines will be published in CENTAC website before the counselling as per instructions received from the competent authority of Government of Puducherry.

### **SLIDING:**

Sliding will be allowed in Round 1 and Round 2 only. No sliding will be allowed during Mop-up round and Stray counselling round. So, Candidates joined upto Round 2 will not be allowed to vacate the seats.

As per NMC guidelines,

The candidates who have joined a seat in Round 2 of State quota counselling or AIQ counselling will not be eligible for the further rounds of counselling. Vide order dated 31/03/2022 the Hon'ble Supreme Court of India in W.P. No. 174 of 2022 issued directions which are as follows:

“(v) In line with the regulations which have been notified on 5 April 2018, students who have joined in round 2 of the state quota or round 2 of the AIQ shall not be eligible to participate in the mop-up round for All India Quota.”

Detailed guidelines will be issued during the concerned round.

If any seat is allotted during sliding after round 1, seat allotted in previous round will be automatically forfeited.

Sliding from one college to another college is permitted during counseling only, based on merit and rule of reservation.

Individual request for transfer of college will not be permitted under any circumstances.

Mutual transfers will not be permitted under any circumstances.

In case of Offline Counselling, due to unforeseen reasons, if a candidate cannot attend the counseling on the specified date and time, he/she can authorize a representative to attend the counseling on his/her behalf. The authorized representative should produce an undertaking and authority letter for allotment along with the requisite original documents. The allotment made to the authorized representative shall be binding on the candidate.

Strict discipline should be maintained by the candidate for smooth conduct of counseling. If the students are found to indulge in any untoward activities, they will be debarred from the counseling and selection, for the present and subsequent academic sessions.

## **15. REGISTRATION FEES**

In addition to the Application fee, For PG Medical (MD / MS) and PG Dental (MDS) counselling, candidates need to pay the **Counselling and Registration fees** for participating in counselling.

**Forfeiture of Registration Fee / Tuition Fee**

(i) After publication of Final allotment list in 2<sup>nd</sup> round, if any candidate fails to join the college then the registration fee as mentioned above will be **forfeited**.

(ii) During mop up counselling, seats will be allotted only after the entire tuition fee is paid to CENTAC. If the student fails to join the allotted college after mop up counselling, then an amount of Rs.2,00,000/- will be forfeited. **In case, the college is not able to fill the seat from the 1:10 list sponsored by CENTAC, then the entire tuition fee will be forfeited.**

(iii) If the college is able to fill the seat, the remaining amount will be refunded after **6 months** so that this acts as a deterrent for blocking of seat. Therefore, it is advised that the candidate makes a thoughtful decision before taking the seat in mop up counselling. **CENTAC reserves**

**the right to modify these guidelines relating to mop up counselling, depending upon necessity.**

**Refund of Registration Fee / Tuition Fee.**

(i) In case the candidate is not allotted any seat during the 2<sup>nd</sup> Round and Mop Up Round, the Registration Fees / Tuition Fees will be refunded to the same account of the candidate from which payment had been made.

(ii) The candidates should keep their bank account active until refund process is completed. The candidates are advised not to use unrelated bank accounts for remitting Registration Fee / Tuition fee amount. CENTAC will not entertain such requests.

**16. FEE STRUCTURE / TUITION FEE**

As prescribed by the “Fee Committee” in Private Medical Colleges for the year 2023-24. Candidates are advised to go through the details of tuition fee notified by the Health Department which will be published in the CENTAC website. Candidates are also advised to go through the notification carefully and verify from the concerned Institution the components not covered in the tuition fee (e.g., Hostel fee, etc.).

**For PG Medical courses, candidates should pay the TUITION FEES to CENTAC account using the payment link in their login dashboard OR use the Account details published in CENTAC website.**

**17. SAVING CLAUSE**

- a. CENTAC reserves the right to issue additional guidelines, or modify or delete the guidelines already issued, based on necessity.
- b. CENTAC shall be the final authority to settle disputes, if any, that may arise.

**18. MODE OF COMMUNICATION**

Any candidate applying for admission to Post Graduate Degree Courses for the year 2023-24 is deemed to have read the content in this prospectus and agrees to all the conditions and clauses and will not have the right to challenge any of the regulations.

The candidates are requested to constantly refer the CENTAC Website [www.centacpuducherry.in](http://www.centacpuducherry.in) for latest updates and announcements. SMS / Email will also be sent regarding updates and announcements. Press release will also be published.

**19. LOWERING OF CUT-OFF**

In case, if the cut-off marks for PG Medical or PG Dental is lowered, then fresh application will be invited and fresh merit list will be drawn.

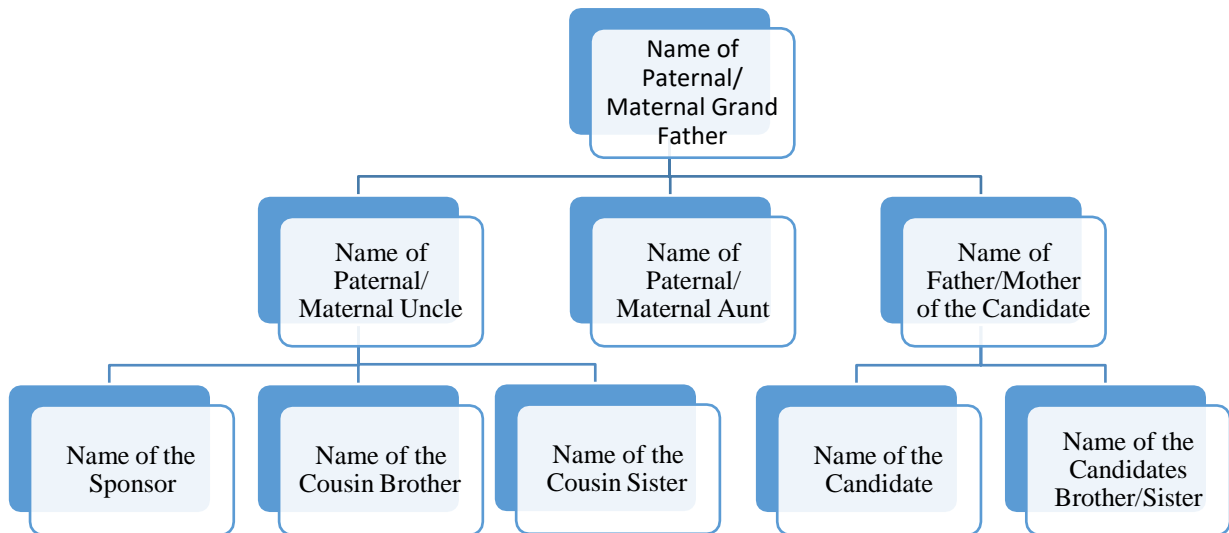

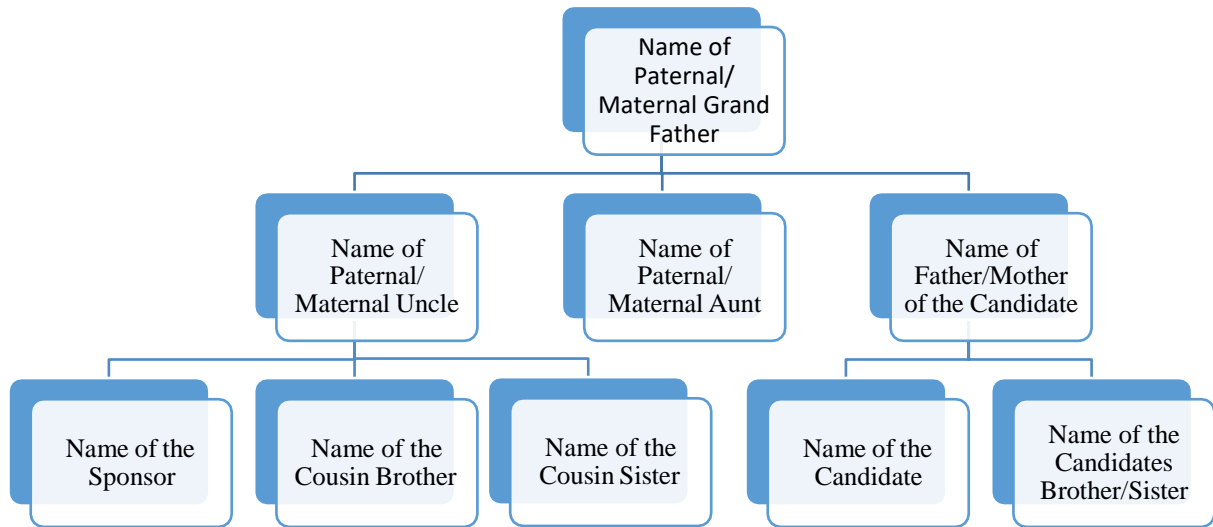
