QUOTA (MQ) PG(DENTAL) SEATS – 2023-24**

**Admissions into Post Graduate Dental Degree/Diploma Courses against Special Stray Vacancy Round to be conducted by Dr. YSR UHS for the academic year 2023-2024 in the State of A.P. under Management Quota Post Graduate Dental Degree / Diploma courses in Private Un-aided Non-minority Dental Colleges affiliated to Dr. YSR UHS.**

The Medical Counselling Committee (MCC), O/o DGHS, Govt. of India, New Delhi vide Notice No.U-12021/02/2023-MEC, Dated: 14-11-2023 notified the Special Stray Vacancy Round Schedule-2023 for admissions into PG(Dental) Courses for the academic year 2023-24 duly extending the last date of admission as 30<sup>th</sup> November, 2023. The MCC further directed the State Counselling authorities to conduct the seat processing for Special Stray Vacancy Round of states after weeding out of candidates ALLOTTED in Special Stray Vacancy Round of MCC, New Delhi.

In view of the above, Dr.YSR UHS invites **Online applications afresh** along with uploading of scanned original certificates from the eligible candidates for Admission into vacant seats of Post Graduate Dental Degree / Diploma Courses under Management Quota in Private unaided Non-Minority Dental Colleges in the State of Andhra Pradesh for the academic year 2023-24.

**Important Note:**

- 1. The Merit Lists both under Competent Authority Quota and Management Quota placed in the University Website and its addendum / corrigendum including Eligible List for Stray Vacancies notified by Dr. YSRUHS are treated as **Null and Void** and only fresh registrations will be considered for this Special Stray Vacancy Round Counselling. The same application will be considered for all the rounds of Special Stray Vacancy counseling, if any.**
- 2. Candidates must join the seat allotted in this special stray round if seat is allotted, failing which candidates shall be debarred for one academic year i.e., 2024-25 for admissions into Dental Colleges in the State of Andhra Pradesh.**

### **Who are eligible to apply for Special Stray Round Counselling:**

- Candidates who are not allotted/holding any PG(Dental) seat either in All India Quota or State Quota are eligible to participate in this special stray round.

### **Who are not eligible to apply for Special Stray Round Counselling:**

- Candidates who have been allotted any PG (Dental) seat in any Phase including Mop Up rounds and stray vacancy rounds conducted by Dr. YSRUHS for Competent Authority Quota (CQ) and Management Quota (MQ) are not eligible to participate in special stray vacancy round.
- Candidate joined / holding any PG (Dental) seat under Dr. YSR UHS / All India Quota / KNR UHS, Telangana / Any Other States are not eligible for this special stray vacancy round.
- Candidates who have not exercised / participated for web options in any Phase of MQ seats of Dr. YSRUHS are not eligible for this special stray vacancy round.

**Note:**

- i) If the names of the candidates found in the list of candidates allotted under Special Stray Vacancy Round by Medical Counselling Committee (MCC) to be shared by MCC on 25.11.2023, they will not be considered under this notification.
- ii) If it is found that an ineligible candidate has opted, candidature of such candidates will not be considered for allotments.
- iii) Registration fee paid will not be refunded under any circumstances.

**Certain Instruction to the students:**

1. For complete details refer Prospectus placed in the website on 04-08-2023.
2. Mere applying under this notification does not confer any right to claim seat and the candidature is subject to availability of seats. Hence, the candidates are advised to take calculated decision before applying under this notification. Fee once paid shall not be refunded under any circumstances.
3. The online application can be filled through any **desktop or laptop** only.
4. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-MDS-2023 Rank.
5. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
6. **Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counsellings.** No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
7. The Candidates are hereby informed that if they have secured admission in Dental colleges of other States, joined the course and if they are involved in blocking of the seats in Dr. YSR UHS, the University will initiate legal action and same will be informed to the Dental Council of India for further course of action.
8. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
