**Special Stray Registration and Fresh application for
PG MEDICAL (MD/MS) for Vacancies
in Self-financing colleges
under GOVERNMENT QUOTA / MANAGEMENT QUOTA**

Vide Notice from DGHS, Govt of India, Ref. U-12021/02/2023-MEC (Pt.II) Dated: 15/11/2023, the Medical Counseling Committee has published the schedule for Special Stray Vacancy Round for admission to post graduate Medical & Dental courses and extended the last date of admission up to 30/11/2023.

In view of above, Special Stray Round Registration for the vacancies published in CENTAC website for admission in PG Medical (MD/MS) courses is open. Using dashboard login credentials, candidates can **submit their willingness along with course preferences and payment of applicable tuition fees on or before 24/11/2023, 5.00pm** after referring to vacancy positions published in CENTAC website.

PG Medical (MD/MS) vacancies under Government quota and Management quota in PIMS, SMVMCH & SVMCH&RI as on 20/11/2023 is published in CENTAC website.

FRESH APPLICATION

Fresh Applications are also invited from NEET (PG) qualified candidates for admission to the first year PG(M.D./M.S.) (Government and Management Quota seats) for the Academic year 2023-24 against the vacancies published in CENTAC website. Interested candidates can **apply online on or before 24.11.2023, 5.00 PM** and **submit willingness and course preferences along with payment of applicable tuition fees.**

Steps for registration for FRESH candidates:

Step 1: Fill the details, pay application fees and submit application.

Step 2 : Submit willingness and course preferences along with payment of applicable tuition fees.

Application Fee (Non-refundable) :

Government Quota : Rs. 3000 /- and Management Quota : Rs. 5000 /.

Existing Candidates

Candidates who have already applied in CENTAC may submit willingness and course preferences along with payment of applicable tuition fees on or before 24/11/2023, 5.00pm.

Existing Government Quota candidates willing to opt for Management quota may update in dashboard and submit willingness and course preferences. But the candidates newly opting for Management quota will be considered as FRESH candidate in Management Merit list.

After exhausting the existing candidates in Government quota and Management Quota merit list, FRESH candidates will be considered for allotment.

Eligibility for Registering Stray Vacancy Round

1. All candidates who have been admitted in Round 1 / Round 2 / Round 3 / Stray round in All India Quota or State Quota are **NOT** eligible for Special Stray round.
2. Candidates who have been allotted any seat in Round 3 or in any Stray round in All India Quota or State Quota and either joined or not joined are **NOT** eligible to apply.
3. Candidates who will be allotted a Seat through Special Stray Vacancy round of MCC will not be considered for this round.

Submission of willingness and course preferences

Both FRESH and EXISTING candidates may participate after submitting willingness, payment of Tuition Fee and filling of Course preferences before 24.11.2023, 5.00 PM.

If course preferences list is empty, the candidate will NOT be considered for allotment.

Payment of Tuition Fee

Sl.No	Quota	Non-clinical (In Rs.)
1.	Government Quota - All candidates	Rs. 655000 /-
2.	Management Quota / Government and Management Quota	Rs. 1305000/-

The candidates are requested to transfer the tuition fee to CENTAC account through NET BANKING or by generating NEFT / RTGS (preferably RTGS) challan using their dashboard login credentials and proceed for payment. Read the HELP Instructions carefully before proceeding for payment.

For candidates paid tuition fee in Round 3 / Stray Round

1. For the candidates who have paid the tuition fee and not allotted any seat and whose amount has been refunded need to pay the applicable Tuition fee again.
2. Those candidates whose earlier paid tuition fee has NOT been refunded/forfeited need NOT pay again.
3. However, the candidates will be considered for allotment based on full payment of applicable tuition fee amount. So, candidates may check and if any balance fee is required to be paid then they should generate challan from dashboard to make payment, based on their course preferences.

Refund / Forfeiture of Fees paid for Special Stray round

- (i) In case the candidate is not allotted any seat during Special Stray round, the Tuition fee paid, will be refunded to the same account of the candidate from which payment had been made.
- (ii) Otherwise, if seat is allotted and the candidate does not join the course, the entire tuition fee amount will be forfeited and such candidate will be debarred from taking NEET exam next year.
- (iii) Therefore, it is advised that the candidate makes a thoughtful decision before submitting course preferences for stray vacancy counselling.
