**State Medical PG Seats (M.D / M.S) / Post MBBS DNB / Post MBBS Diploma Allotments-2024**  
**Round 3**

In continuation to the earlier notifications and MCC Notice no. U-12021/05/2024-MEC, dated 04.01.2025 informing about decision taken by MoHFW in consultation with NMC reducing the percentile for NEET PG counselling 2024, schedule for round 3 allotment process for MD/MS, Post MBBS DNB and Post MBBS Diploma courses in Rajasthan, will be as below:

**Schedule for Allotment process (Round 3)**

<p><b><u>Application form</u></b> On-line Application form filling for candidates who have not registered earlier as well as <b>who have now become eligible due to reduction in qualifying percentile</b></p> <p>Start date for filling of on-line application form and deposition of required <b>application fee</b></p> <p><b>It is a mandatory step for subsequent process of counseling and allotment.</b></p> <p><b>Both the parts (Part 1 and Part 2) of the application form must be filled and completed.</b></p> <p><b><u>Those candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may now complete the same.</u></b></p> <p><b><u>Those who are already registered/have applied need not register/apply again.</u></b></p> <p>Note: A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3, will be eligible only on fresh application and on depositing security amount again. Notification for date and time for re-registration will be released in due course of time.</p>	<b>18.01.2025</b>

<p>Deposition of security amount (refer the Instructions Booklet for details)</p> <p>Candidates who deposited the applicable security amount in Round 1 / Round 2 (except candidates whose security deposit was forfeited due to non-joining in Round 2) are not required to deposit it again but those candidates who did not deposit the applicable security amount in Round 1 / Round 2 or wish to deposit the applicable difference amount (based on type of seat/course/college) must deposit it now (as the case may be) on-line, failing which they will not be considered for allotment on a seat/seat type in a college.</p> <p>A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3, will be eligible only on fresh application and on depositing security amount again. His/her earlier deposited security amount will be forfeited. Notification for date and time for deposition of security amount will be released in due course of time.</p>	18.01.2025 to 25.01.2025 (4.00 pm)
<p>On-line choice filling, locking of the choices by the candidates (including filling up and saving of the choices / changing the filled choices multiple times)</p> <p>Note: <b>Choice filled by candidate in Round 1 / Round 2 will not be considered for Round 3 allotment.</b></p> <p><b>While filling the choices for round 3, participating candidates must remember to fill the choices also for the virtual vacancies that may arise due to upgradation by a joined candidate of earlier round.</b></p> <p>Following candidates are eligible for Round 3 and must fill choices to participate in Round 3:</p> <ol style="list-style-type: none"> <li>1. Earlier registered candidates who did not get allotment in both the rounds (i.e. Round 1 and Round 2)</li> <li>2. Round 1 candidate allotted and joined but resigned after declaration of round 2 result, without forfeiture of security amount</li> <li>3. Joined candidates of Round 1 / Round 2 who wish to upgrade (with fresh registration and with security amount deposition, notification in this regard will be issued in due course of time)</li> <li>4. Newly registered candidates</li> </ol> <p>Note: Joined candidates of Round 2 who do not wish to upgrade and wish to retain their Round 2 seat need not fill choices in Round 3.</p> <p>If a round 1 / round 2 allotted and joined candidate does not fill choices for round 3 (as per the applicable procedure), then he/she will not be considered for upgradation in round 3 (as per his/her merit) and the seat allotted to him/her in round 1 / round 2 will be considered retained as such.</p>	18.01.2025 to 26.01.2025 (11.45 pm) <b>(choices auto-locked at 11.45 pm on 26.01.2025)</b>

Publishing of provisional seat matrix (after Sr. Demonstrator allotments)	To be notified after receipt of merit list from NBE
Printing of the on-line application form after auto-locking of the choices filled and saved by the candidates	27.01.2025 onwards

Deposition of prescribed one year tuition fee by allotted candidates through NEFT and RTGS only (No other mode of fee deposition will be accepted)  Refer <b>Important Advice for online payment of Security Amount/Tuition Fee</b> available at the website. <b>Reporting, document submission</b> (including prescribed eligibility criteria) <b>at the allotted college desk at Academic Block, SMS Medical College, Jaipur</b> along with printout of allotment letter, all original documents, required bonds etc. and 2 copies of application form along with Self attested photocopies (one set) of all relevant documents as listed in information booklet  <b>Note:</b> (i) Round 2 joined candidates who get upgraded in Round 3 shall bring fee receipt issued by Round 1 / Round 2 joined college and will complete all other formalities of allotted college (their original documents will be transferred directly to Round 3 upgraded college).  (ii) Round 2 joined candidates who filled choices for upgradation but not upgraded to Round 3 (allotted same college and same course in Round 3) need not report again for the same college. 1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. All concerned / fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
3. A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible only on fresh application and on depositing security amount again. His/her earlier deposited security amount will be forfeited.
4. **All PwD candidates** must present themselves physically for document verification before the admission board on the notified date as per the notification and the list to be made available at the website.
5. **All Eligible Senior Demonstrators** who have deposited requisite security amount must present themselves physically with all applicable original documents for verification and allotment before the admission board on as per the notification.
6. All such candidates having joined status upto Round 2 who retain their seat in Round 3, will have to complete all other formalities of their allotted college (Refer to respective College Website) at the time of joining for Round 3.
7. The candidates are advised to visit the websites regularly for registration and other relevant information.

**Important:**

**For candidates willing to participate/upgrade in Round 3, it is mandatory to fill fresh choices in Round 3 (irrespective of whether the candidate was allotted/joined a seat in Round 1 / Round 2 or not).**

**The choices filled by candidate in Round 2 shall be scraped and will not be considered for Round 3. If a candidate does not fill fresh choices for Round 3, then he/she will not be considered for allotment/upgradation in Round 3.**
