This petition is filed seeking directions to the respondents to comply with the decision dated 14.06.2017 issued by the Medical Council of India that all lab reports be signed/counter-signed by persons registered with Medical Council of India/State Medical Council. The petition is pending since 2017.
- 2. Learned counsel for the parties are at ad-idem that the Supreme Court in Special Leave to Appeal (C) No(s).28529/2010 (North Gujarat Unit of Association of Self Employed Owners (Paramedical) of Private Pathology Laboratories of Gujarat VS. North Gujarat Pathologists Association & Ors.) and other connected matters vide order dated 12.12.2017 has disposed of the special leave to appeals by passing the following order:-

"Heard learned counsels for the parties. Delay condoned.

We dispose of all these special leave petitions and other pending applications, if any, by taking a view that the stand of the Medical Council of India that Laboratory Report can be counter signed only by a registered medical practitioner with a post graduate qualification in pathology is correct."
