Q. No.1 - Whether Up-gradation is allowed in Stray Vacancy Round counseling ?
Ans. Upgradation is not allowed.

Q.No.2: Who are not eligible for Stray Vacancy Round?
Ans. Following categories of Candidates are not eligible for Stray Vacancy Round:-
a) Candidates who have not registered for Stray Vacancy Round.
b) Candidate joined/holding any seat at the time of Stray Vacancy Round.
c) Candidates allotted a seat in Round 3 and NOT REPORTED. All candidates not falling under above-mentioned categories are eligible.
