## Q.No.2: Who are not eligible for Stray Vacancy Round?

Ans. Following categories of Candidates are not eligible for Stray Vacancy Round:-

- a) Candidates who have not registered for Stray Vacancy Round.
- b) Candidate joined/holding any seat at the time of Stray Vacancy Round.
- c) Candidates allotted a seat in Round 3 and NOT REPORTED. All candidates not falling under above-mentioned categories are eligible.
