The candidate who have already registered but not holding any seat of Round I, II & III (as per applicable rules) need not apply again. Date for fresh online registration/application and deposition of application and security deposit for fresh applicants alongwith fee of Rs. 5000+18%GST(Rs. 5900/-) and Rs. 2500+18%GST(Rs. 2950/- for SC candidates) through university payment portal. (Fresh registered candidates will have to submit willingness alongwith security deposit for Stray Vacancy online counseling. Failing which their candidature will not be considered.	25.10.2024 to 27.10.2024 (upto 02:00 PM)
3.	The last date for submitting willingness alongwith security deposit for Stray Vacancy round of counselling by all the candidates (already registered candidates and fresh applicants). The amount of security to be deposited for submitting willingness will be as under: For Government colleges - Rs. 10000/- (half for SC/BC) For both Govt. & Private Colleges – Rs. 2,00,000/- For Private Colleges – Rs. 2,00,000/-	25.10.2024 to 28.10.2024 (upto 05:00 PM)
4.	Last date for submitting admission application form for NRI quota (Application form for getting Eligibility certificate and admission application form for NRI candidates is separately available on University website)	28.10.2024 (upto 05:00 PM)
5.	The candidates who will apply under Sikh Minority/Christian Minority Quota will report to the respective minority institution (SGRD Institute of Medical Sciences, Amritsar / Christian Minority College, Ludhiana) for verification of minority status. The candidates who have already got verified their minority status at the time of 1 st , 2 nd & 3 rd counseling, need not report to the respective institute for verify again. The candidates who have already registered under Minority Quota during 1 st & 2 nd & 3 rd counseling and did not get their minority status verified, can report to the respective institute for verification of their minority status for Stray Vacancy Round of counseling.	26.10.2024 to 27.10.2024 (upto 04:00 PM)

9.	Display of provisional allotment / Result Note: As per schedule of MCC Stray Vacancy round counseling, they will show the joined candidates data of State(s). The final allotment will be declared after debarring the joined candidates (if any) from the provisional allotment of Stray Vacancy Round of Punjab State.	04.11.2024
10.	The provisionally selected candidates will pay the balance amount of fee (Six month fee after deducting amount of security deposit) through university payment gateway available on university website and will report to the respective college for joining in the respective allotted college.	05.11.2024

Note: The security deposit of candidates who do not join the allotted seat in Stray Vacancy Round will be forfeited and such candidates will be debarred from taking NEET exam for the next year.

1 Q. No.1 - Whether Up-gradation is allowed in Stray Vacancy Round counseling?

Ans. Upgradation is not allowed.

2 Q No: Who are not eligible for Stray Vacancy Round?

2 Ans. Following categories of Candidates are not eligible for Stray Vacancy Round:-

- a) Candidates who have not registered for Stray Vacancy Round.
- b) Candidate joined/holding any seat at the time of Stray Vacancy Round.
- c) Candidates allotted a seat in Round 3 and NOT REPORTED. All candidates not falling under above-mentioned categories are eligible.

Note: Already registered candidates who have deposited security amount in 2nd & 3rd round counselling and to whom no seat is allotted in 2nd & 3rd Round, need not to deposit security amount again. **However, they will have to submit willingness to participate in Stray Vacancy Round, through online portal of the University.**
