**Admission Process for Undergraduate Health Science Courses
for Academic Year 2025-26**

[MBBS/BDS/BAMS/BHMS/BUMS/BNYS/BPTH/BOTH/BASLP/B (P&O)]

The Admission Process for Government / Government Aided/ Corporation/ Private Unaided & Minority Institutions for Health Science Courses in the State of Maharashtra will be carried out by Commissioner & Competent Authority, State Common Entrance Test Cell, Mumbai.

Filling up of the Online Registration form with all the relevant information and necessary fees is mandatory for applying for admission to various health science courses including {MBBS/ BDS/ BAMS/ BHMS/ BUMS/ BNYS/ BPTH/ BOTH/ BASLP/ B(P&O)}. **Candidates not filling up the Online Registration Form shall not be considered for admission to any quota of these courses.**

- Candidates should upload all the requisite original scanned documents.
- It will be the sole responsibility of the candidate to upload all the necessary documents and familiarize herself/himself with online preference filling system for admission to Health Science Courses.
- Candidates should also ascertain her/his eligibility for admission to the various courses before filling up the registration form.
- PWD candidates should have claimed the quota at the time of NEET. They should submit Online PWD certificate issued by any one of the 16 boards.
- As per G.R. of General Administration Department ROD-4019/C.R 31/ 16- A, dated 12 February 2019 and Government Resolution no. MED-1018/C.R 37/19/Edu- 2, dated 07th March, 2019. "EWS" means Economically Weaker Section, include persons who are not covered under the scheme of reservation for SC, ST, DT-A, NT-B, NT-C, NT-D, OBC (Including SBC) & SEBC.
- Candidates belonging to reservation category must claim so in the application form before submitting the same.
- Any claim for converting from Open/General category to reserved category after submission and payment shall not be entertained.
- NRI candidate should register on [Foreign Candidate Registration Portal](#) before 29/07/2025 for verification of candidate's eligibility. The subsequent schedule will be as above.
- NRI candidates should note that they are eligible only for 15% Institute Quota as per merit.
- All The candidates should visit State CET Cell official website i.e. www.mahacet.org for updates.
