**GENERAL INSTRUCTIONS:**

- ❖ **Candidates who are participating in this counseling should abide by the rules of this round of counselling.**
- ❖ Candidates who are participating the online choice filling for PG Degree/Diploma Courses will have to remit a non-refundable Registration Fee of Rs.1000/- for Government Quota and Rs.1000/- for Management Quota.
- ❖ At the time of registration, the candidate will have to pay Refundable Security Deposit (If already paid need not pay again) for Government Quota:

For Government Medical Colleges	– Rs. 30,000/-
For Government Quota seats in Self-Financing Medical College	– Rs. 1,00, 000/-

- ❖ At the time of registration, the candidate will have to pay Refundable Security Deposit (If already paid need not pay again) for Management Quota:

For Management Quota including Minority/ NRI Category seats in Self-Financing Medical Colleges	- Rs.2,00, 000/-

- ❖ All candidates should read the Prospectus thoroughly before starting choice filling.
- ❖ Candidates should be careful while choice filling.
- ❖ As per prospectus clause 34(e), if there are no eligible Service candidates opting for PG Degree / Diploma courses, the same will be allotted to eligible General category candidates.
- ❖ As per prospectus clause 34(h), any remaining unfilled seats for want of adequate number of eligible candidates belonging to SCA community shall be filled by candidates belonging to SC community as per merit vice versa (G.O. (Ms) No. 55, P & A R Dept. Dated 08.04.2010). Hence SC candidates can register and choice lock for remaining unfilled SCA seats also.
- ❖ As per prospectus clause 34(i), any remaining reserved seats in ST quota for want of adequate number of eligible candidates belonging to ST community shall be filled by candidates belonging to SC community as per merit (G.O.(Ms) No.77, H & FW Department, dated 24.02.2011. Hence SC candidates can register and choice lock for remaining unfilled ST seats also.

- ❖ As per prospectus clause 34(j), any remaining unfilled seats in BCM community for want of adequate number of eligible candidates after exhausting the merit list shall be filled up on merit basis by candidates belonging to BC community without exceeding the quota for BC community as a whole (G.O. (Ms) No.30, H & FW Dept. dated 18.01.2012). Hence BC candidates can register and choice lock for remaining unfilled BCM seats also.
- ❖ Any unfilled seats of NRI, Telugu Minority, Malayalam Minority and Religious minority including CMC 50% minority seats, will be filled under Management Quota.
- ❖ **The candidates if allotted a seat in round 3 in Govt. Colleges / Govt. Quota seats in Self Financing Colleges, will be blocked for allotment of Self Financing Colleges under Management Quota and DNB Broad Speciality Courses.**
- ❖ **The candidates who have joined in All India Quota Round 3 will be blocked if the joined list of Round 3 is shared by DGHS.**

#### **Up-gradation in Mop-up Round (Round 3)**

- ❖ Candidates holding Round 1 / Round 2 seats who have not resigned can go for Up-gradation in Mop-Up Round (Round 3).
- ❖ Candidates of Round 1 / Round 2 who were allotted a seat and not joined can participate in Mop-up Round (Round 3)
- ❖ The candidates who wish to retain the college taken in first & second round of online counseling need not participate in Mop-Up Round (Round -3) of counseling.
- ❖ **Choice Filling:** Candidates will have the option of choice filling for all the seats for which they have applied to. For example, if a candidate has applied for both Government and management quota he will have choices for both Government as well as Management quota. The candidates are encouraged to analyze all the choices available and fill their choices in order of their preference.
- ❖ Candidates can edit their choices any number of times before locking, but once locked they will not be allowed to edit. Hence candidates are requested to check their choices and the order of preference before locking.
- ❖ If the candidate does not lock his/her choices till the last date (14-02-2026 03.00 PM) their choices will be automatically locked.

- ❖ **Virtual Vacancies-** Any Candidate who has been allotted a seat in Round 1 / Round 2 and has opted for upgradation in Mop up (Round 3), that allotted seat of Round 1 / Round 2 will be shown as virtual vacancy in Mop up (Round 3), any Candidates can choice lock for the said seat (virtual seat) during the choice filling in Mop up (Round 3). However, such seat will be allotted in Mop up (Round 3) only if the allotted candidate of Round 1 / Round 2 vacates that seat. Thus, that virtual vacancy becomes real vacancy and it is open to all in the order of merit.
- ❖ **Any candidate who has opted for upgradation in Mop-up (Round -3) and allotted a seat in Mop-up round (Round-3), the candidate will necessarily have to vacate the seat and cannot claim for retaining the seats.**
- ❖ Vacancy position for the Courses will be available on the official websites.
- ❖ Selection committee does not take responsibility for Connectivity error and Procedural error.

- ❖ Admission to PG Degree/ Diploma courses shall be made by the ONLINE COUNSELLING on the basis of rank by applying the rule of reservation.
- ❖ Request for change of course or College, from one to another is not permitted after final locking.

### **INSTRUCTIONS FOR DOWNLOADING ALLOTMENT ORDER:**

- ❖ The freshly allotted candidates have to pay the Tuition Fee for downloading the Provisional allotment order through online via Debit Card / Credit Card/ Net Banking.
- ❖ Fee structure is available on the official website [www.tnmedicalselection.net](http://www.tnmedicalselection.net)
- ❖ All candidates should make sure, sufficient fund is available at their bank account with expanded credit limit while remitting their Tuition Fee.
- ❖ The re-allotted candidates who have already paid the tuition fee in the Round 1 & Round 2 of online counseling, will have to pay the difference (if any) amount only.
- ❖ The re-allotted/allotted candidates should download their provisional allotment order and join the course in the concerned Medical College/Institution on or before the stipulated date and time as mentioned in the Provisional Allotment Order.

### **REPORTING TO ALLOTTED COLLEGE:**

- ❖ The candidates should produce their ORIGINAL CERTIFICATES in person at the time of joining in their selected Colleges along with the scanned copy of original certificates for verification.
- ❖ If you do not report to the Head of the Institution to which you are allotted on or before the time and date specified, your selection and / or admission will be cancelled without any further notice.
- ❖ The Candidate selected for admission should give a self-declaration form at the time of the reporting to the concerned College that he/she is liable for forfeiture of selection / admission if suppression of facts, mis-interpretation is found at any time during or after the admission to the course.
