In view of above referred letter from National Commission for Indian System of Medicine, Ministry of AYUSH, Government of India has reduced the minimum qualifying percentile in AIA PGET-2023 for admission in Post Graduate Ayurveda, Homoeopathy & Unani courses for Academic Year 2023-24 is as follows.
