Not of Standard Quality (NSQ) drugs:

The drugs that fail to meet the quality standards or specifications are known as Not of Standard Quality (NSQ) drugs.

(Further, the term 'standards of quality' is defined under the Section 16 (1) (a) of Drugs & Cosmetics Act, 1940, that the 'standards of quality' mean that the drug complies with the standards set out in the Second Schedule of the said Act.)

Misbranded Drugs:

Drugs shall be deemed to be misbranded—

- if it is so coloured, coated, powdered or polished that damage is concealed or if it is made to appear of better or greater therapeutic value than it really is; or
- if it is not labelled in the prescribed manner; or
- if its label or container or anything accompanying the drug bears any statement, design or device which makes any false claim for the drug or which is false or misleading in any particular.

The term "Misbranded Drug" has been defined under Section 17 of the Drugs and Cosmetics Act, 1940.
