Further, please note that, no any written /email communication will be entertained in this regards and no written communication will be made to the applicant(s) /candidate(s) or to any SIP center by the University. Hence, for any updates and information, it will be the duty of the concerned applicant/enrolled SIP center to visit the University website regularly and check the details.

In view of the feedback and responses from previous year it has been decided by the MUHS that, allotment of the student(s) will be done on pro-rata basis, considering the number of applications received from each faculty so that sufficient representation to each faculty students can be done.
