**UPON hearing the counsel the Court made the following  
O R D E R**

**I.A NO. 132614/2022 IN W.P (c) NO. 267/2017**

1 The following two reliefs have been sought in the IA which has been moved by the Medical Counseling Committee:

“a) Clarify the order dated 09.05.2017 in W.P. no. 267 of 2017 in the matter of Dar-Us-Slam Educational Trust v. MCI & Ors. to the extent that there shall be four rounds of common counselling for AIQ seats conducted by MCC,

DGHS which is in congruence with the modified scheme of counselling as laid down in the order dated 16.12.2021 in SLP no. 10487 of 2021 in the matter of Nihila P.P. v. MCC & Ors.;

- (b) Direct/permit the MCC of DGHS, MoHFW to conduct online counselling for stray vacancy round for 100% Deemed Universities in NEET Under Graduate and Post Graduate course.”

2 Having heard Ms Aishwarya Bhati, Additional Solicitor General, we direct that for 100% deemed universities:

- (i) There shall be four rounds of common counselling for the All India Quota seats conducted by the Medical Counseling Committee; and
- (ii) The Medical Counseling Committee is permitted to conduct an online counselling for the stray vacancy round.

3 The above directions shall take effect from the ensuing academic year 2022-23.

4 The IA is accordingly disposed of.
