Petition under Section 151 of CPC praying that in the circumstances stated in the affidavit filed in support of the Writ Petition, the High Court may be pleased suspend the operation of G.O.Ms. No. 107 dated 28/07/2023 issued by the 1st respondent, pending disposal of Writ Petition No.22368 of 2023, on the file of the High Court. /

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). /

ORDER:

“This is an application filed seeking the Court to suspend the operation of G.O.Ms.No.107, Health, Medical and Family Welfare (C1) Department, dated 28.07.2023.

Heard Sri Sandeep Reddy Sama, learned counsel for the petitioners, Sri Sri K.Uday Kumar, learned Assistant Government Pleader for Health, Medical and Family Welfare, who is representing Respondent No.1; Sri Katika Ravinder Reddy, learned Standing Counsel for Telangana Admission and Fee Regulatory Committee (TAFRC), who is Respondent No.3; Sri Srinivas Pachwa, learned counsel representing Respondent No.5; Sri Gandra Mohan Rao, learned Senior Counsel who is representing Respondent No.6; Sri Raghu Ram, learned Senior Counsel who is representing Respondent Nos.10 & 11 and Smt.Lakshmi, learned counsel who is representing Respondent No.19.

The counsels, who made their submission, argued at length with regard to the merits of the matter. Learned counsels appearing for Respondent Nos.1 to 3, 5, 6, 10, 11 & 19, during the course of their submission, contended that the Writ Petition itself is not maintainable as the Court has limited power to put the Government orders to scrutiny.

The submission made by learned counsel for the petitioners, on the other hand, is that the Government, through the impugned G.O. vide G.O.Ms.No.107, Health, Medical and Family Welfare (C1) Department, dated 28.07.2023, has fixed exorbitant fee for the Medical students to pay and therefore, the present Writ petition is maintainable.

A perusal of the entire material that is brought on record goes to show that certain amount of fee is fixed for the Post-Graduate Education of Medical and Dental courses for the block period 2023-2026 through the impugned G.O. and the same is challenged.

The contention of the learned counsel for the petitioners is that the fee fixed for Education i.e. for the Post-Graduate studies of Medical and Dental students is exorbitant and is under challenge. This Court is of the view that for some of the courses and professions, the legislative, by its wisdom, has addressed the professions and the courses and their duties as services and not as business. Medical Services is one among them. Therefore, when the students pursuing their Education to render Medical services are charged with certain amount of fee, which according to those students is exorbitant and when those students approach this Court challenging the fee fixed for them to pursue their education, this Court is of the view that Article 226 of the Constitution of India comes into play for rendering a decision whether such fee charged for pursuing Education to render future services by those students is sustainable or not. Therefore, this Court holds that the present Writ Petition is maintainable.

Coming to the merits of the matter, learned counsel for the petitioners states that for the block period 2023-2026, a fee structure for Post- Graduate Medical and Dental courses is fixed to be collected by the Private, Unaided, Non-Minority and Minority Medical and Dental Colleges in the State of Telangana. Learned counsel states that the fee fixed through the impugned G.O. i.e., G.O.Ms.No.107 Health, Medical and Family Welfare (C1) Department,

dated 28.07.2023 is exorbitant and further, the fee fixed is not in accordance with the procedure that is required to be followed. Learned counsel has brought to the notice of this Court the fee that was fixed for the same course in the years 2010, 2016, 2017 and 2020. Learned counsel further states that through G.O.Ms.NO.20, Health, Medical and Family Welfare (C1) Department, dated 14.04.2020, an exorbitant fee structure is laid down for the block period 2020-2023. The said G.O. was challenged before this Court and this Court passed interim orders in W.P.No.6799 of 2020, dated 26.05.2020.

Further, stating that the procedure that was ordered to be followed was not followed, learned counsel brought to the notice of this Court the order that was rendered by this Court in the case between *Consortium of Engineering Colleges Managements Association (CECMA), Hyderabad and others Vs.State of Andhra Pradesh and others*¹. In the said decision, on analyzing all the relevant factors, statutory provisions, reports and recommendations of Admission and Fee Regulatory Committee (AFRC), this Court issued certain guidelines to be followed. Placing reliance upon the said guidelines, learned counsel for the petitioners states that none of the guidelines were followed. Learned counsel submits that the details of fee proposals were not placed in Public Domain and were not published in the Newspapers. Learned counsel also states that as per the guidelines, the State Government shall issue the fee structure notifications by the first week of March preceding the Academic year or the block of academic years. But, such fee structure notification was not issued. Admittedly, the impugned G.O. was issued in the month of July, 2023. None of the counsels appearing for the respondents stated that the guidelines, as laid down, were followed.

Learned counsel appearing for Respondent No.3 had stated that G.O.Ms.No.20, dated 14.04.2020, was issued without reference to the recommendations made by TAFRC. However, the present G.O. is issued basing on the recommendations made by TAFRC.

Though learned counsel appearing for Respondent No.6 states that the subject decision i.e., the decision that is referred by learned counsel for the petitioners regarding implementation of the guidelines as laid down in the

decision that is referred by the learned counsel for the petitioners were stayed by the Hon'ble Supreme Court, a perusal of the order in SLP (Civil) Nos.34050 - 34080 of 2011 goes to show that the operation of the direction contained in Clause (xvi) in respect of Academic year 2010-11 and 2011-12 is only stayed.

Proceeding with his further submission, learned counsel for the petitioners has submitted that there is abnormal increase in the fee structure and the fee was increased by 179% to 296%, both in Convener Quota as well as Management Quota and therefore, intervention of this Court is required. It is brought to the notice of this Court that W.P.No.6799 of 2020, where earlier G.O. i.e., G.O.Ms.NO.20, Health, Medical and Family Welfare (C1) Department, dated 14.04.2020 was challenged, is still pending. Admittedly, pending such Writ Petition and also where an interim order is passed directing the concerned Authorities to collect only part of the fee that is liable to be paid, the impugned G.O. is issued indicating similar fee structure.

Having considered the submission that the guidelines issued were not followed while fixing the fee structure and as the fee fixed through earlier G.O. i.e., G.O.Ms.NO.20, dated 14.04.2020 is under challenge and as the impugned G.O. i.e., G.O.Ms.No.107 is issued making reference to G.O.Ms.No.20, whose operation is stayed, this Court is of the view that the interim order is required to be passed to facilitate the petitioners to take admission. Also, the inconvenience of the institutions should also be considered.

Therefore, the Interlocutory Application is disposed of with the following direction:-

(i) For the candidates belonging to category-A, fee shall be collected @ 60% of the amount that is payable as per the impugned G.O. i.e., G.O.Ms.No.107, Health, Medical and Family Welfare (C1) Department, dated 28.07.2023.

(ii) For the candidates belonging to category-B, fee shall be collected @ 70% of the amount that is payable as per the impugned G.O. i.e., G.O.Ms.No.107, Health, Medical and Family Welfare (C1) Department, dated 28.07.2023.

(iii) The candidates, who fall within the ambit of either Category-A or Category -B, shall at the time of payment, furnish a personal bond

undertaking to pay the remaining amount on disposal of the present Writ Petition, in case, the same is required to be paid.

(iv) In case any of the candidates have already deposited the fee entirely, they cannot claim for refund of the amount immediately. However, request for refund shall be entertained on disposal of the Writ Petition and in case they are entitled for such refund."
