It was brought to the Notice of the Director of Medical Education, Telangana State that the (43) Doctors were on Unauthorised absence in the various institutions. Accordingly the Show Cause Notice for Termination of Services in the references 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> cited. An Enquiry Committee was also constituted providing opportunity to approach the authorities for submitting explanation and rejoining to duties vide reference 4<sup>th</sup> cited. The Enquiry Committee also submitted their report within the stipulated time recommending for termination of services of the following (38) Doctors.

In view of the above the following (38) Doctors are liable for termination as per provisions under Rule 5-B Telangana Leave Rules-1933 read with GO Ms. No. 128 Finance (FR.I) Dept dated: 01.06.2007 and Rule 10 (e) of Telangana State and Subordinate Service Rules -1996. Hence the Doctors mentioned below are herewith directed to submit their explanations if any within (7) Days as to why their services may not be terminated with immediate effect. If no reply is received from the individual within stipulated time, it shall be construed that he/she has no explanation to offer and their services will be treated as Terminated from date of unauthorised absence:
