Transfer (after 1st MBBS) of Medical Students in the state of Maharashtra (2021-2022) – Regular & Supplementary Batch

This notification is for all the desirous candidates seeking transfer to another Medical college after passing the first MBBS examination. All such candidates who have passed first MBBS examination conducted in March 2022 (Regular Batch) and August 2022 (Supplementary Batch) by Maharashtra University of Health Sciences, Nashik or from any Deemed University situated in the state of Maharashtra, should apply online (on website-www.med-edu.in) along with prescribed fees Rs. 15,000/- from 10.01.2023 to 31.01.2023. After the last date of submission of application, 04 (Four) days period will be given for the late submission of application i.e. 01.02.2023 and 04.02.2023. However during this 4 (Four) days period the applicant has to pay application fee Rs. 15,000/- plus late fee RS. 10,000/- total Rs. 25,000/-. Candidate has to make payment through Online via NEFT / RTGS / UPI or Internet banking. The detail of bank is given below;
