Subject: - Conduct of Second (upgradation/allotment) Round of (Physical) Counselling for Admission to NEET UG (MBBS/BDS) courses 2022 including Hindu Minority seats in ASCOMS.

Reference: - (i) Notification No. 084-BOPEE of 2022 dated 16-11-2022

Notification No. 089-BOPEE of 2022 Dated 22-11-2022

Consequent upon receipt of shortfall from the Medical/Dental Colleges of the UT of Jammu and Kashmir in respect of Notification No. 084-BOPEE of 2022 dated 16-11-2022 due to non-joining of candidates who had been allotted MBBS / BDS seats, it is hereby notified that the Board shall conduct the Second Round of Physical Counselling for NEET-UG-2022 to fill up the vacant seats including the seats under HM (Hindu Minority) in ASCOMS as per the following schedule:-

Further as a consequence of the order passed by the Hon'ble Court on 15.11.2022 in WP (C) NO.776/2022, whereby the interim Order dated 18.04.2022 has been vacated and the writ petition has been dismissed, (with the direction that a seat for the petitioner shall be reserved for petitioner for a period of two weeks from the issuance of order or till further orders of the court) it is notified for the candidates belonging to CDP Category (Children of Defence Personnel) that the seats reserved for the CDP category not dispensed with during the online round of counseling (barring one reserved as per court directions) shall also be allotted during the second round of Physical Counselling on 25^{th} of November, 2022.

The candidates belonging to CDP category who have registered themselves along with genuine category certificates and found their place in PML shall present themselves before the Board at Jammu/Srinagar on (Friday) 25.11.2022 along with valid CDP Category (Priority Certificate) from the competent authority to substantiate their claim as per inter-se-priority.

The candidates participating in the physical round of counselling shall have to report at BOPEE Office, Jammu / Srinagar from 08:30 a.m to 10:30 a.m on their respective day of counselling. The candidates who are participating for the first time in the counselling shall also have to pay Counselling Fee of Rs. 1500/- through POS machines available in the BOPEE Office Jammu/ Srinagar on their respective date of counselling.

The Following Candidates shall be eligible to participate in the Second round of physical counselling:

- Candidates who have joined the course / Institution allotted to them during the first round of counselling.
- Candidates who participated in first round of online counselling but did not get a seat owing to Choice Not Available (C.N.A) / Seat Not Available (S.N.A) at their turn of online counselling.
- Candidates who figure in the **Provisional Merit List** but have not participated in the first round of online counselling.
- The candidate who have applied under HM in ASCOMS in pursuance of Notification No. 085-BOPEE of 2022 dated 17-11-2022.

The Following Candidates shall not be eligible to participate in the Second round of physical counselling:

- Candidates who did not join the course / Institution allotted to them during the first round of online counselling.
- Candidates whose names do not figure in PML as per Notification No. 074-BOPEE of 2022 dated 04-11-2022.

Note:

- 1. Candidate(s) participating in the physical round of counselling who did not get a seat or a seat is allotted to him / her, should in his / her own interest not to leave the counselling section/area of the Board office on his /her day/date of counselling as there is a possibility that a seat of his/her choice, which was not earlier available on his /her turn of counselling may become available during the process. He /she can stake a claim on such a seat immediately on same day/date of the counselling rooms of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant and shall be added to the seat matrix and filled up accordingly as per merit / preference. The Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as mentioned above on the same day and he/she shall not be eligible to stake claim against the seat which shall became vacant during next day of counselling.
- 2. Any candidate who misses the counselling on the particular date of his/her turn shall be allowed to participate on the next day of counselling but he/she shall get the seat whatsoever available at that point of time and he/she shall not be eligible to stake a claim

on the seat, which otherwise he/she would have been allotted at his/her own turn of counselling notwithstanding his/her merit cum preference.

- 3. The unfilled seats under Hindu Minority Quota in ASCOMS shall be filled up during the process of physical counselling from amongst the eligible candidates who have submitted valid documents strictly as per their merit-cum-preference.
- 4. The Tentative Seat Matrix to be operated upon during the second round of counselling shall be made available on BOPEE website <u>www.jkbopee.gov.in</u> before the start of physical counselling.
- 5. The Rule-17 of the reservations rules is not applicable in 2nd Round of counselling.
- 6. All eligible candidates are advised to go through the seat matrix available on the official website of the BOPEE before approaching the BOPEE office at Jammu/Srinagar.

The other terms and conditions shall remain the same as notified by the Board in e-Information Brochure, notifications and notices issued by the Board from time to time.
