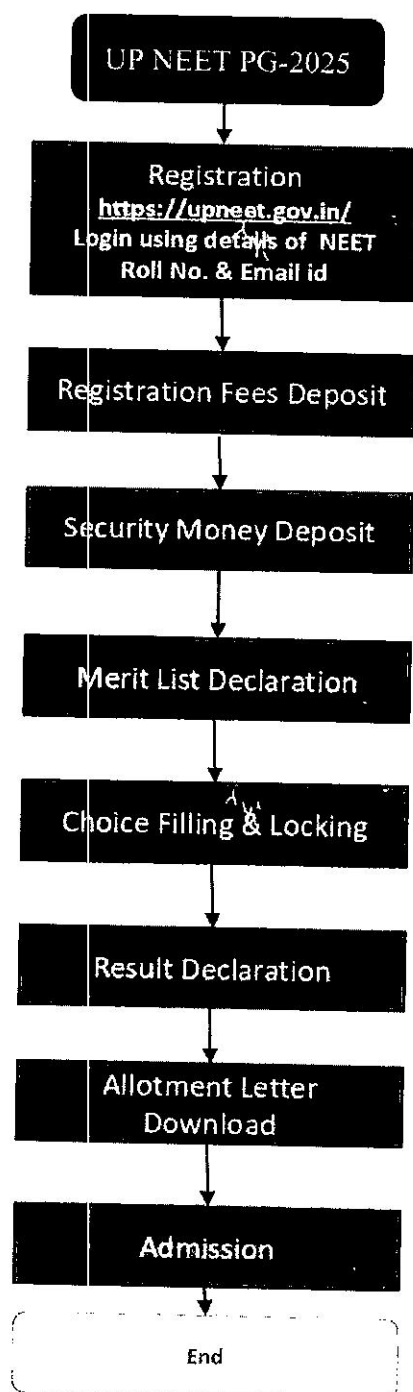

## **Chapter-2: Eligibility**

- Candidates who have qualified NEET-PG-2025/NEET-MDS-2025 entrance examination.
- Candidates who have completed their one year of Compulsory Rotatory Internship on or before by **31<sup>st</sup> March 2025** for MDS and **31<sup>st</sup> July, 2025** for MD/MS /Diploma/DNB courses.
- Candidates who have passed MBBS/BDS course from the Govt/Private Medical & Dental Colleges of U.P. are eligible for Government State Quota seats and Private Medical College seats.
- Candidates who have passed MBBS/BDS from AMU, Aligarh, BHU, Varanasi, AIIMS Raebareli and AIIMS Gorakhpur are not eligible for admission in Government State Quota Seats. Such candidates are eligible for admission only in Private Medical & Dental Colleges/ Institutes/Universities.
- Candidates who have passed MBBS/BDS from *outside of Uttar Pradesh* are eligible for admissions only in Private Medical & Dental Colleges/Institutes/Universities.
- A candidate who has already taken admission on the basis of earlier NEET- PG/ NEET- MDS entrance examination is not eligible for the NEET PG-2025/ NEET-MDS-2025 counseling until he/she completes and passes the course where he/she is presently admitted.
- Only those NEET qualified In-service (PMHS) candidates, whose list is provided by Director General Health Services under policy framed by Department of Medical Health & Family Welfare Government of Uttar



Pradesh, are eligible for due weightage as per norms, will be eligible for UP NEET PG-2025 counselling.

- Only In-service (PMHS) candidates are eligible for state quota DNB seats.
- Foreign Medical Graduates (FMG) & Foreign National Candidates are eligible for UP NEET PG-2025 counselling as per eligibility criteria mention in NBE Information Bulletin-2025 point no. **4.10 & 4.11.**

**4.10- ELIGIBILITY CRITERIA FOR FOREIGN MEDICAL GRADUATES:**


Indian citizens or overseas citizens of India who have obtained their Primary Medical Qualifications from Medical Colleges outside India should have qualified the Foreign Medical Graduate Examination (Screening Test) as per Screening Test Regulations, 2002 which is conducted by National Board of Examinations in Medical Sciences. Further, they should have been registered with the NMC/ the erstwhile Medical Council of India or State Medical Council and should have completed their internship or likely to complete their internship on or before 31<sup>st</sup> July 2025.

**4.11. ELIGIBILITY CRITERIA FOR FOREIGN NATIONALS:**

**4.11.1-** Their basic Medical Qualification equivalent to MBBS should be recognized by the NMC.

**4.11.2-** Foreign Nationals desirous of appearing in NEET-PG and those, who are required to have security clearance as per the Ministry of Home Affairs (MHA) requirements, shall obtain the security clearance from Ministry of Home Affairs, Govt. of India before applying for NEET-PG. The security clearance shall be required to be submitted while applying for NEET-PG.

**4.11.3-** The NMC may, on payment of the prescribed fee for registration, grant temporary registration for the duration of the Post Graduate course limited to the medical college/institution to which he/she is admitted for the time being exclusively for pursuing postgraduate studies. Provided further that temporary registration to such foreign national shall be subject to the condition that such person is duly registered with appropriate registering authority in his own country where from he has obtained his Basic Medical qualification, and is duly recognized by the corresponding Medical Council or concerned authority and Permission/No Objection Certificate from the medical council of that country to allow undertaking Post Graduation in India has also been obtained.



### **Chapter-3: Reservation**

- Reservation will be given as per directions of Government of Uttar Pradesh vide **Govt. Order No.- I/986212/2025, Dated- 06/06/2025.**

- Reservation Policy of the State Government for the NEET PG-2025 counselling in Government State Quota seats is as follows:

#### **Vertical Reservation:**

- ❖ S.C.-21%
- ❖ S.T.-2%
- ❖ O.B.C - 27%
- ❖ EWS- 10%

#### **Horizontal Reservation:**

- ❖ PwD- 5%

- The list of SC/ST/OBC categories shall be as notified by the Government of Uttar Pradesh as applicable at the time of counselling.
- Reservation of seats under PwD Category is 5% in Government State Quota Seats and the 21 Benchmark Disabilities as envisaged under the regulations of Rights of Persons with Disabilities Act 2016 and as per the NMC norms.
- Candidates who want to avail 5% PwD reservation in PG seats of Govt. medical institutions should obtain Disability certificate as per 21 Benchmark Disabilities given under RPWD Act 2016 and as per NMC norms, from the designated disability centres.
- PwD Certificate issued by any other Hospital/ Board will not be acceptable.
- All certificates related to reservation will be valid only on the format prescribed by the Government of Uttar Pradesh and issued by the competent authority of Uttar Pradesh.
- For EWS and OBC category, certificates issued only on or after April 01, 2025 will be valid.
- Reserved category candidates of other states will be treated as unreserved category candidate for UP NEET PG/MDS counselling-2025.



## **Chapter-4: Registration Process**

- Only online registration will be permissible on website <https://upneet.gov.in>.
- Candidates are advised to fill the registration form on their own/self on the UPNEET website and not through any agent or third party.
- For registration, candidate will use his/her NEET-PG Roll No. & same email ID used by them during registration on NBE website for NEET PG-2025/ NEET MDS-2025 entrance examination and follow instructions on website.
- Candidate's data like Name, Father's Name, Mother's Name, Date of Birth etc. at the time of registration on NBE portal will be pre-populated and will be used for counselling purposes. No request to change these details will be entertained.
- There after Registration form will be displayed, candidates have to enter only his/her domicile, category, subcategory, In-service (PMHS) employment status and MBBS passed from, address etc.
- Candidate will make payment of Registration fee only once of Rs. 3,000/- for 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> round of counselling.
- All eligible candidate requires fresh registration for Stray vacancy round separately with Registration fee of Rs. 3,000/-
- Registration fee is non-refundable.
- After successful submission of registration form, registration number will be generated.
- During Registration process candidates will create a Password for choice filling and locking of the choices. Candidates are hereby advised not to share/disclose the password to anyone.



- Once the registration process is successfully completed, candidates are advised to download their Registration form & Registration fee slip for future reference.

### **Security Fee:**

1. For Govt. Medical & Dental Colleges/Institutes/ Universities- Rs. 30,000/- [Thirty Thousand]
  2. For Pvt. Medical Colleges/Institutes/ Universities- Rs. 2,00,000/- [Two Lakhs]
  3. For Pvt. Dental Colleges/Institutes/ Universities- Rs.1,00,000/- [One Lakh]
- If security fee is not submitted by candidate, then he/she will not be permitted for choice filling.
  - After successful payment, download security money receipt for future reference.

## **Chapter-5: Merit list & Choice Filling**


- Merit list for MD/MS/Diploma candidates will be prepared after providing weightage to In-Service (PMHS) candidates as per the provisions of **Govt. Order No.- I/986212/2025, Dated- 06/06/2025.**
- Merit list for DNB & MDS candidates will be prepared on the basis of their All-India NEET Rank.
- Candidates are advised to obtain detailed information regarding the private colleges in which they intend to seek admission, prior to their choice filling.

### **Online Choice filling:**

- For choice filing visit website <https://upneet.gov.in> and login by using NEET Roll number and Password created at the time of registration.
- Candidate can fill as many choices as he/she wishes. Candidate can change his/her choice until the final locking.
- Choice filing will not complete till candidates finally submit and lock their choices within scheduled time.
- **Choice Locking is compulsory, if not locked then online allotment will not occur.**
- Once the choice is locked, it can not be altered/modified/changed.

### **Seat Allotment:**

- After scheduled period of choice filling, seat allotment will be done on the basis of merit cum choice filled by the candidates.



- Seat allotment status of successful candidates will be displayed on website <https://upneet.gov.in>.
- Allotted candidates will have to download the allotment letter before reporting at allotted Medical College /Dental College/ Designated Nodal Centre.
- In the first round of counselling if candidate does not take the admission to the allotted seat, candidates will be allowed for free exit.
- If Candidate has secured the admission after first round of counselling in the allotted college but wants to reshuffle his/her seat/college, then he/she will remain eligible for upgradation of seat up to third round of counseling.
- If the candidate is trying for upgradation, it is advised not to fill choice for same seat/college in which candidate is already admitted. In case if candidate fills the same seat/college in the reshuffling rounds and the candidate is allotted same seat again, then previous allotment would automatically be cancelled.
- It is mandatory to take admission in the new allotted seat, if candidate does not take admission in the new (re-shuffled) seat, the new allotment will get cancelled.
- The conversion of seat will be carried out during the 3<sup>rd</sup> round of counseling for State quota. The said conversion will be done only when the candidates belonging to the said conversion category have exhausted. The algorithm for conversion of category is as follow:

### **Stray Vacancy Round**

- Candidates who are allotted any seat from UP NEET PG/MDS 2025 counselling but not joined/admitted/ resigned will not be eligible to participate in the UP NEET Stray vacancy Round.
- Any candidate who has taken admission in any PG course in any Medical & Dental College in India through AIQ counselling or other state quota counselling will not be eligible to participate in the UP NEET Stray vacancy Round.
- Fresh registration with Rs 3000/- is mandatory for Stray vacancy round and only these candidates will be included in the Stray vacancy merit list.
- If a candidate is allotted a seat in Stray round, candidate has to report & join the allotted seat/ college else he/ she shall be debarred from UPNEET PG/MDS Counselling-2026 along with forfeiture of security deposit.

## **Chapter-6: Admission Process**

- Candidates have to complete their admission Process including fees deposition at allotted Government Medical & Dental Colleges or Nodal center mentioned in allotment letter.
- It will be mandatory for the candidates who have been allotted the seats in Private Medical & Dental College/Institute/University (except minority Institutions) to deposit the tuition fee fixed by the government at the time of admission. In minority Colleges/Institutions, it will be mandatory for the candidates to deposit the tuition fee prescribed by the respective Colleges/Institutes.
- If candidate does not take admission to the allotted seat by the due date, he/she shall forfeit any right of admission on the basis of said counseling/allotment.
- Candidates will have to produce all original academic & category certificates at the time of admission.
- Candidates who fail to produce required original documents at the time of admission or if any concealment or falsification of facts comes to the light at the time of admission or thereafter during the academic sessions, it will make the candidate lose his/her candidature and he/she would be subjected to legal action.
- Following documents in original and one set self-attested photocopy will be deposited at the time of admission:
  1. Copy of Allotment letter
  2. Admit Card of NEET PG-2025/ NEET MDS-2025
  3. Score card/Rank letter of NEET PG-2025/ NEET MDS-2025
  4. High School Marksheet/Certificate (as proof of date of birth)
  5. Mark sheets of all professional examinations of MBBS/BDS
  6. MBBS/BDS passing out certificate or degree
  7. Compulsory Rotatory Internship completion certificate
  8. Permanent / Provisional Registration Certificate (State Medical council /MCI/DCI)
  9. Reservation certificate (SC/ST/OBC/EWS/PwD certificate), if applicable.
- **Refund process of security money for eligible candidates will commence only after the completion of all the round of counselling.**



## **Chapter-7: Resignation**

- Resignation will only be acceptable as per directions of Government of Uttar Pradesh vide **Govt. Order No.- I/986212/2025, Dated- 06/06/2025.**

- i. त्याग-पत्र देने हेतु वही अभ्यर्थी अर्ह होंगे, जिनके द्वारा आवंटन के पश्चात् प्रवेश प्रक्रिया पूर्ण की गयी हो। अभ्यर्थी द्वारा प्रवेश प्रक्रिया जिस कालेज/नोडल सेन्टर पर सम्पन्न की गयी थी, उसी कालेज/नोडल सेन्टर पर अभ्यर्थी को व्यक्तिगत रूप से उपस्थित होकर त्याग-पत्र देना होगा। किसी भी अन्य माध्यम से प्रेषित किया गया त्यागपत्र मान्य नहीं होगा।
- ii. राजकीय मेडिकल कालेजों/डेंटल कालेजों/नोडल सेन्टर के प्रभारी अधिकारी समस्त त्याग-पत्र नियमानुसार स्वीकार करते हुए एन0आई0सी0 के पोर्टल पर निर्धारित समयान्तर्गत अपडेट करेंगे। पोर्टल पर अपडेट किये गये त्यागपत्र ही मान्य होंगे।

### **(क) प्रथम चक्र की काउन्सिलिंग:-**

- i. यदि कोई अभ्यर्थी प्रथम चक्र की काउन्सिलिंग से आवंटन प्राप्त कर प्रदेश के किसी भी राजकीय/ निजी क्षेत्र की मेडिकल कालेज/डेंटल कालेज की सीट पर प्रवेश प्राप्त कर लेता है तत्पश्चात् वह प्रवेशित सीट से त्यागपत्र देना चाहता है, तो ऐसे अभ्यर्थी द्वितीय चक्र की काउन्सिलिंग के च्वाइस फिलिंग से दो दिन पूर्व **(उदाहरणार्थ यदि द्वितीय चक्र की काउन्सिलिंग की च्वाइस फिलिंग 24 जुलाई 2025 को पूर्वाह्न 11:00 बजे से प्रारम्भ है, तो अभ्यर्थी 22 जुलाई 2025 को पूर्वाह्न 11:00 बजे तक)** अपनी सीट से त्यागपत्र दे सकता है। ऐसी स्थिति में अभ्यर्थी को निःशुल्क निर्गमन (Free exit) की सुविधा होगी, अर्थात् अभ्यर्थी की सम्पूर्ण धरोहर धनराशि अभ्यर्थी को वापस कर दिया जायेगा। साथ ही राजकीय क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु प्रवेश शुल्क को छोड़कर तत्समय जमा समस्त शुल्क अभ्यर्थी को वापस कर दिया जायेगा एवं निजी क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु तत्समय जमा शिक्षण शुल्क अभ्यर्थी को वापस कर दिया जायेगा।
- ii. प्रथम चक्र से प्रवेशित कोई अभ्यर्थी यदि प्रथम चक्र की काउन्सिलिंग हेतु निर्धारित तिथि व समय के पश्चात् त्याग-पत्र देता है, तो ऐसे अभ्यर्थियों पर द्वितीय चक्र की काउन्सिलिंग से संबंधित त्यागपत्र के प्राविधान लागू होंगे।

### **(ख) द्वितीय चक्र की काउन्सिलिंग:-**

- i. राजकीय तथा निजी क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु प्रदेश की द्वितीय चक्र की काउन्सिलिंग समाप्त होने के पश्चात् अभ्यर्थी तृतीय चक्र की काउन्सिलिंग के च्वाइस फिलिंग से दो दिन पूर्व तक अपनी सीट से त्यागपत्र दे सकता है। ऐसी स्थिति में अभ्यर्थी द्वारा जमा की गयी सम्पूर्ण धरोहर धनराशि जब्त कर ली जायेगी। साथ ही राजकीय क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु प्रवेश शुल्क को छोड़कर तत्समय जमा समस्त शुल्क अभ्यर्थी

को वापस कर दिया जायेगा एवं निजी क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु तत्समय जमा शिक्षण शुल्क अभ्यर्थी को वापस कर दिया जायेगा।


- ii. प्रथम/द्वितीय चक्र से प्रवेशित कोई अभ्यर्थी यदि निर्धारित तिथि व समय के पश्चात् त्याग-पत्र देता है, तो ऐसे अभ्यर्थियों पर तृतीय चक्र की काउन्सिलिंग से संबंधित त्यागपत्र के प्राविधान लागू होंगे।

**(ग) तृतीय चक्र की काउन्सिलिंग:-**

- i. राजकीय क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु प्रदेश की तृतीय चक्र की काउन्सिलिंग समाप्त होने के पश्चात् किसी भी अभ्यर्थी को सीट रिक्त करने की अनुमति नहीं होगी, फिर भी यदि अभ्यर्थी स्ट्रे वैकेन्सी राउण्ड के च्वाइस फिलिंग से दो दिन पूर्व अपनी सीट से त्याग पत्र देता है, तो अभ्यर्थी द्वारा जमा की गयी सम्पूर्ण धरोहर धनराशि तथा तत्समय जमा किये गये समस्त शुल्क जब्त कर लिया जायेगा।
- ii. निजी क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु प्रदेश की तृतीय चक्र की काउन्सिलिंग समाप्त होने के पश्चात् किसी भी अभ्यर्थी को सीट रिक्त करने की अनुमति नहीं होगी, फिर भी यदि अभ्यर्थी स्ट्रे वैकेन्सी राउण्ड के च्वाइस फिलिंग से दो दिन पूर्व अपनी सीट से त्याग-पत्र देता है, तो अभ्यर्थी द्वारा जमा की गयी सम्पूर्ण धरोहर धनराशि जब्त कर लिया जायेगा साथ ही उसके द्वारा तत्समय जमा किये गये शिक्षण शुल्क का 50 प्रतिशत जब्त कर लिया जायेगा।
- iii. प्रथम/द्वितीय/तृतीय चक्र से प्रवेशित कोई अभ्यर्थी यदि निर्धारित तिथि व समय के पश्चात् त्याग-पत्र देता है, तो ऐसे अभ्यर्थियों पर स्ट्रे वैकेन्सी राउण्ड की काउन्सिलिंग से संबंधित त्यागपत्र के प्राविधान लागू होंगे।

**(घ) स्ट्रे वैकेन्सी राउण्ड:-**

राजकीय/निजी क्षेत्र के मेडिकल कालेजों/डेंटल कॉलेजों हेतु स्ट्रे वैकेन्सी राउण्ड के पश्चात् अथवा पाठ्यक्रम पूर्ण करने से पूर्व यदि कोई अभ्यर्थी अपनी सीट से त्याग-पत्र देता है, तो अभ्यर्थी द्वारा जमा की गयी सम्पूर्ण धरोहर धनराशि तथा तत्समय जमा किया गया समस्त शुल्क जब्त कर लिया जायेगा। यदि अभ्यर्थी को धरोहर धनराशि वापस की जा चुकी है, तो वह भी अभ्यर्थी को वापस करनी होगी। धरोहर धनराशि डिमाण्ड ड्राफ्ट के द्वारा महानिदेशक, चिकित्सा शिक्षा एवं प्रशिक्षण, उत्तर प्रदेश लखनऊ के पक्ष में देय होगी।







## **Chapter-8: Service Bond**

- Candidates taking admission in Government Medical or Dental colleges are required to mandatorily serve the bond in the state of Uttar Pradesh, as per the Government Order issued by the Government of Uttar Pradesh.
- According to Government Order No. 950/71-2-82/2017 dated 07.03.2018, as amended from time to time, candidates taking admission in postgraduate courses are required to sign a bond agreement for compulsory service. The details of the bond are as follows:

### **Debarment: -**

- शासनादेश संख्या-1/676928/2024 दिनांक 26 जून 2024 के क्रम में राजकीय क्षेत्र के मेडिकल कालेजों/डेंटल कालेजों हेतु यदि सम्बन्धित अभ्यर्थी द्वारा अन्तिम चक्र की काउंसिलिंग के पश्चात् पाठ्यक्रम पूर्ण करने से पूर्व सीट छोड़ी जाती है, तो उसे अगले शैक्षणिक सत्र की प्रवेश प्रक्रिया से Debar कर दिया जायेगा।




