As per the GOs read as 1st ,3rd ,4th & 5th paper above above, Government have mandated the documents to be submitted by candidates seeking admission under the NRI category for Medical Courses.

2) Considering the recommendations of the Admission Supervisory Committee and the Commissioner for Entrance Examinations, Government are pleased to order that the NRI students shall submit the following documents in addition to the documents mentioned in the GOs read above for admission to the Medical courses;

- i. Resident Identity Card: In cases where visas are not stamped on passports (e.g UAE), the Resident Identity Card shall be accepted in

lieu of the visa, without the requirement of attestation from the Indian Embassy/Consulate General.

- ii. Employment Proof: The Resident Identity Card or Golden Visa shall be considered as valid proof for the Employment Certificate.
- iii. Sponsorship Certificate: Documents attested by Embassies abroad shall have a validity of six months. In case of a discrepancy between the employer's name in the Sponsorship Certificate and the Resident Identity Card, the CEE/Concerned Authorities shall conduct a verification, seek explanations from the applicant, and take appropriate decisions based on the information gathered from the relevant institutions.
